

GENERAL DESCRIPTION

The EPIC 3 RI VOICE AMPLIFIER and EPIC 3 *BLUETOOTH* LAPEL SPEAKER MIC (LSM) provide facepiece voice amplification and wireless voice communications when connected to a portable two-way radio (supplied by the user). The EPIC 3 RI (Radio Interface) COMMUNICATION ASSEMBLIES are intended for installation only on approved SCOTT respirators equipped with SCOTT full facepieces with dual voicemitters. Training is required before use. These assemblies are not intended for use under water or for any purpose not specifically authorized by the organized respiratory program that applies to the specific user.

The EPIC 3 RI COMMUNICATION system consists of:

- <u>EPIC 3 RI VOICE AMP</u> Facepiece mounted, battery powered voice amplifier with integrated *BLUETOOTH* wireless technology;
- <u>EPIC 3 BLUETOOTH LSM</u> BLUETOOTH wireless technology equipped transmitter fitted with a specific two-way radio communication cable and connector; and
- <u>TWO-WAY Portable radio</u> Compatible two-way portable radio (supplied by user).

The voice amplifier device attaches to the voicemitter bracket mounted on either side of an approved Scott Safety full facepiece. Accessory mounting brackets are available for compatible SCOTT respirator facepieces not already equipped with voicemitter brackets.

Both the RI VOICE AMP and the *BLUETOOTH* LSM assemblies require three (3) approved AAA batteries installed. The complete system requires (3) AAA Batteries each for a total of six (6) AAA batteries.

The RI VOICE AMP must be paired with the *BLUETOOTH* LSM to establish the wireless link. When connected to a *BLUETOOTH* LSM with portable two-way radio, pressing the large push-to-talk button on the *BLUETOOTH* LSM will activate the push-to-talk function of the two-way portable radio. The RI VOICE AMP will transmit the amplified voice communications over the portable two-way radio.

In the event that the RI VOICE AMP is lost or damaged during use, the *BLUETOOTH* LSM can continue to function as a remote speaker mic with the portable two-way radio after the *BLUETOOTH* pairing link with the RI VOICE AMP has been disconnected. Refer to the EMERGENCY OPERATION section of this instruction for details.

Certain *BLUETOOTH* LSM models are equipped with a RED Emergency Button to operate the corresponding emergency alert feature on compatible portable radios. Refer to the user manual for your portable two-way radio for details of use. If the RED Emergency Button is not installed on your unit, that feature is not available.

LED's on the RI VOICE AMP assembly and the *BLUETOOTH* LSM assembly light to indicate operation. To conserve battery life, the RI VOICE AMP assembly features an automatic power OFF feature that shuts off the power after twenty (20) minutes of inactivity.

When the *BLUETOOTH* LSM assembly is connected to a portable two-way radio, the use of the assembly/radio combination in flammable atmospheres is limited to the most restrictive hazardous location listing applicable to the two devices. If the *BLUETOOTH* LSM assembly is connected to a non-intrinsically safe radio, the combination may not be used in flammable or explosive atmospheres.

The *BLUETOOTH* LSM assembly is available in a variety of cord/connector configurations to fit popular brands and models of portable two-way radios. Each configuration has a unique part number representing the radio specific connector used to attach it to the portable two-way radio for which it was designed. Do not attempt to attach an *BLUETOOTH* LSM assembly to a portable two-way radio for which it was not designed.

Optional Push-To-Talk Paddle and Push-To-Talk Ring accessories can be actuated when worn under an encapsulating protective garment. 



EPIC 3 BLUETOOTH LSM

BATTERY USE

Both the RI VOICE AMP and *BLUETOOTH* LSM assemblies require battery power to operate. This comes from three (3) approved AAA batteries installed. The complete system requires three (3) AAA Batteries for each of the two units for a total of six (6) AAA batteries.

NOTE

THE RI VOICE AMP AND *BLUETOOTH* LSM ARE SHIPPED FROM THE FACTORY WITH ALKALINE BATTERIES INSTALLED AND A BATTERY ISOLATOR LABEL TO PREVENT BATTERY DRAIN. REMOVE THE BATTERY ISOLATOR LABEL BEFORE USE.

TO REMOVE BATTERY ISOLATOR:

- **RI VOICE AMP:** Open the battery door to pull isolator label from battery compartment. Close and secure the battery door before use
- BLUETOOTH LSM: Pull isolator label from battery compartment.

LOW BATTERY ALERT

Total battery life is dependent on conditions of use.

The RI VOICE AMP LED will flash RED and chirp at 20 second intervals to indicate that the batteries are low. After 60 minutes the blink rate will increase to 10 second intervals and the unit will chirp at a slightly louder volume .

- If paired with the BLUETOOTH LSM, the LED will flash alternating RED and GREEN.
- If NOT paired with the BLUETOOTH LSM, the LED will flash RED ONLY.

WHEN THE LED IS FLASHING, AND IS EMITTING A CHIRP, CHANGE THE BAT-TERIES IMMEDIATELY.

The *BLUETOOTH* LSM will flash RED to indicate that the batteries are low when approximately one hour of operating time remains.

- If paired with the RI VOICE AMP, the LED will flash alternating RED and GREEN.
- If NOT paired the RI VOICE AMP, the LED will flash RED ONLY.

WHEN THE LED IS FLASHING CHANGE THE BATTERIES IMMEDIATELY.

WARNING

WHEN THE LOW BATTERY INDICATION APPEARS (FLASHING RED ONLY OR FLASHING ALTERNATELY BETWEEN RED AND GREEN AND ACCOMPANIED BY A CHIRP) CHANGE THE BATTERIES IMMEDIATELY. The RI VOICE AMP Assembly requires three AAA batteries installed in the microphone/ speaker unit. Use only three fresh batteries from the following lists.

Rechargeable Batteries:

- Duracell Rechargeable (NiMH) DC2400

Alkaline Batteries:

- Eveready Energizer¹ Max E92
- Eveready Energizer Industrial EN92
- Duracell² Copper Top MN2400
- Duracell Pro-Cell PC2400
- Rayovac³ 824

Do not mix battery types, old and new batteries, or batteries from different manufacturers. When using rechargeable batteries, verify that they are fully charged before use. Use of any other batteries except those listed will void the intrinsic safety listing of the RI VOICE AMP Assembly. The area must be known to be nonflammable and safe before opening the battery door.

NOTE

THE RI VOICE AMP IS SHIPPED FROM THE FACTORY WITH ALKALINE BATTERIES INSTALLED AND A BATTERY ISOLATOR LABEL TO PREVENT BATTERY DRAIN. OPEN THE BATTERY DOOR AND REMOVE THE BATTERY ISOLATOR LABEL BEFORE USE. (REFER TO BATTERY USE SECTION OF THIS INSTRUCTION.)

Install batteries as follows:

- 1. Use a #1 Phillips screwdriver to open the battery door. Turn the battery door screw counterclockwise. Lift open the hinged door.
- Inspect the contacts for corrosion or damage. If any discrepancy is found, do not use the unit. Return to an authorized SCOTT repair center for service.
- Insert the batteries into the battery compartment. Be sure to check orientation of + and - polarity of batteries as marked on the outside of the battery compartment.
- 4. Verify that the seal around the battery door is clean and undamaged.
- 5. Close the battery door.
- 6. Turn the screw clockwise to tighten until snug. Do not over tighten.
- 7. Press the POWER Button for one (1) second to turn the RI VOICE AMP ON. The GREEN POWER LED will illuminate indicating the amplifier is ON and the unit will sound a sequence of ASCENDING tones based on the programming of the unit (4 tones for Open Bracket and 5 tones for Closed Bracket). If the LED does not illuminate, verify that ALL the batteries are fresh AND that they are properly installed. The unit may emit a high pitched tone (feedback) as the Auto Gain function sets the optimum output.

If the LED is flashing RED, the batteries are low and must be changed before use of the RI VOICE AMP.

- 8. To verify proper operation, speak into the microphone port in the D-shaped mount. The voice should be heard amplified coming from the speaker.
- 9. To turn OFF the RI VOICE AMP, press and HOLD the Power Button for three (3) seconds. The unit will sound a sequence of two (2) DESCEND-ING tones to indicate the unit is OFF and the LED will go OFF.

The BLUETOOTH LSM Assembly requires three AAA batteries installed in the battery holder. Use only three fresh batteries from the following lists.

Alkaline Batteries:

Rechargeable Batteries:

- Duracell Rechargeable (NiMH) DC2400
- Eveready Energizer Industrial EN92
- Duracell² Copper Top MN2400

- Eveready Energizer¹ Max E92

- Duracell Pro-Cell PC2400
- Rayovac³ 824

Do not mix battery types, old and new batteries, or batteries from different manufacturers. When using rechargeable batteries, verify that they are fully charged before use. Use of any other batteries except those listed will void the intrinsic safety listing. The area must be known to be nonflammable and safe before opening the battery door.

- Inspect assembly for damage. Check contacts inside the Battery Compart-2. ment for dirt, corrosion, or damage. Clean as needed. If any damage beyond the scope of this instruction is found, do not use unit. Return to authorized SCOTT repair center for service.



- Place batteries in battery compartment. Check orientation of + and -3. polarity of batteries as marked in the bottom of battery compartment.
- Verify that the seal around the inside of the battery compartment is 4 clean and undamaged. If the gasket or battery door is damaged, refer to the *REPLACEMENT OF BLUETOOTH LSM BATTERY DOOR* section of CLEANING AND MAINTENANCE in this instruction for replacement details.
- 5. Close the battery door. Using a Phillips screwdriver, tighten the two battery door screws until they are snug. DO NOT OVERTIGHTEN.

CONNECT THE BLUETOOTH LSM TO A TWO-WAY PORTABLE RADIO TO CONFIRM THAT THE BLUETOOTH LSM IS OPERATING PROPERLY.

- 6. Attach BLUETOOTH LSM assembly to portable two-way radio and turn radio ON according to user instructions provided with portable two-way TIGHTEN THE SCREWS ONLY UNTIL THEY ARE radio. The LED on the BLUETOOTH LSM will light GREEN when radio has been turned ON. If the LED does not illuminate, repeat steps 1-6. Verify that ALL the batteries are fresh AND that they are properly installed. If it still does not illuminate, remove from service and tag for repair or replacement.
- Proceed to the PAIRING THE EPIC 3 RI VOICE AMP WITH THE EPIC 7. 3 BLUETOOTH LSM section of this instruction.

PROGRAMMING THE EPIC 3 RI VOICE AMP

The RI VOICE AMP communications assembly is designed for use with a SCOTT Full Facepiece equipped with voicemitters and a compatible SCOTT AUDIO ACCESSORY BRACKET. The AUDIO ACCESSORY BRACKETS are available as either OPEN or CLOSED front depending on the approved facepiece being used. In addition, the RI VOICE AMP may be powered by approved batteries that are either Alkaline or Rechargeable NiMH.

For proper performance, the RI VOICE AMP must be programmed for the type of ACCESSORY BRACKET and Batteries being used.

Each RI VOICE AMP is preprogrammed at the factory for use with Alkaline batteries and either an OPEN accessory bracket or CLOSED accessory bracket configuration. RI VOICE AMPS programmed for open brackets will emit 4 tones upon startup and amps programmed for closed bracket will emit 5 tones.

If the RI VOICE AMP is to be used with a bracket style different from the original factory setting or with Rechargeable NiMH Batteries, the unit must be reprogrammed for proper performance with the correct configuration.

To change the programming of the RI VOICE AMP, proceed as follows:

- 1. Use a #1 Phillips screwdriver to open the battery door. Turn the battery door screw counterclockwise. Lift open the hinged door.
- 2. While holding down the POWER Button, close the battery door. Continue holding the POWER Button until the LED lights ORANGE.
- 3. Once the power button is released, the RI VOICE AMP will emit a long audible tone to indicate that the unit is now in Programming Mode. The LED on the amplifier will then light according to the current setting.

If any operational problems are found that may relate to the programming, remove the RI VOICE AMP from the facepiece and repeat the programming as instructed above to verify that the proper changes are saved. If the programming is verified and the unit still does not operate properly, remove the unit from service and tag for repair.

PAIRING THE EPIC 3 RI VOICE AMP WITH THE EPIC 3 BLUETOOTH LSM

The RI VOICE AMP utilizes integrated *BLUETOOTH*[®] wireless technology to communicate with the *BLUETOOTH* LSM. Linking the units is referred to as "pairing". After the initial "pairing" procedure, RI VOICE AMP and *BLUETOOTH* LSM will search for the same unit to connect with each time either unit is powered on. To pair the RI VOICE AMP assembly with the *BLUETOOTH* LSM assembly, proceed as follows:

- 1. Verify that both the RI VOICE AMP assembly and the *BLUETOOTH* LSM assembly have fresh batteries.
- 2. Attach the *BLUETOOTH* LSM assembly to the portable two-way radio. If any accessory is connected to the *BLUETOOTH* LSM assembly, remove it before proceeding.
- 3. Turn ON the RI VOICE AMP unit by pressing and holding down the POWER button approximately three to four (3–4) seconds until the LED turns from GREEN to ORANGE. Proceed to the next step immediately. If no activity is detected within thirty (30) seconds, the RI AMP will time out and turn itself off.
- 4. Press and hold the Push-To-Talk button on the BLUETOOTH LSM. While holding down the Push-To-Talk button, turn ON the two-way portable radio according to manufacturer instructions. Release PUSH-TO-TALK button when the LED turns from GREEN to ORANGE.
- 5. Place the RI VOICE AMP and *BLUETOOTH* LSM within close proximity, no more than 12" apart.

NOTE

THE *BLUETOOTH* LSM WILL PAIR WITH THE FIRST RI VOICE AMP THAT IT LOCATES. TO AVOID A LINK TO A UNIT OTHER THAN THE INTENDED RI VOICE AMP, AVOID PAIRING WITHIN 6 FEET OF OTHER UNITS.

- 6. The LED on **both** units will begin to flash ORANGE.
- 7. Once a link is established both LED's will flash twice and then change to solid GREEN. Upon establishing link, the unit will also emit an audible tone. If no link was established within thirty (30) seconds the LED on RI VOICE AMP will turn a solid ORANGE and the LED on the *BLUETOOTH* LSM will turn off. If the units DO NOT pair, repeat steps 1–6. If they still do not pair, remove them from service and tag for repair or replacement.
- 8. The RI VOICE AMP and the *BLUETOOTH* LSM will remain paired to the same unit until they are paired with other units. Changing batteries will not affect the paired units.
- 9. To pair a RI VOICE AMP with a different *BLUETOOTH* LSM, repeat the procedure above.

The RI VOICE AMP facepiece assembly may be used with any approved SCOTT respirator which includes a full facepiece equipped with dual voicemitters. Installation includes pairing the Facepiece assembly with the *BLUETOOTH* LSM assembly, mounting the facepiece assembly on the facepiece, connecting the *BLUETOOTH* LSM assembly to a portable two-way radio via the cord and radio connector, securing the *BLUETOOTH* LSM to the protective gear, and placing the portable two-way radio on the user's person.

 See AUDIO ACCESSORY MOUNTING BRACKET INSTALLATION IN-STRUCTIONS (P/N 595107-01 closed bracket; P/N 595287-01 open bracket) for details of attaching the mounting bracket to your SCOTT full facepiece. Verify that bracket is properly mounted for your SCOTT full facepiece before proceeding. On the AV-2000 facepiece, pay special attention to the free movement of the head harness tabs.

NOTE

THE RI VOICE AMP ASSEMBLY WILL ONLY FIT ON AUDIO ACCESSORY BRACKET P/N 200264-XX AND P/N 200265-XX OR SERVICE KIT BRACKETS P/N 200715-XX, P/N 200716-XX, AND P/N 201210-XX.

- 2. The body of the RI VOICE AMP facepiece assembly is keyed so that it fits in the mounting bracket only one way. Attach the facepiece assembly to the mounting bracket as follows:
 - a) Hold the RI VOICE AMP with the battery compartment door facing the top right harness tab.
 - b) Align the D-shaped mount on the rear of the amplifier with the opening in the center of the audio accessory bracket and press in.
 - c) While pressing the Accessory in towards the side of the facepiece rotate the Accessory 1/4 turn counter clockwise. The lock will make two (2) "clicks". The second "click" will lock the accessory into place.
 - d) To verify that the RI VOICE AMP is properly locked, try to rotate the accessory clockwise WITHOUT lifting up on the Locking Lever. If the Accessory will not turn, it is properly locked.
 - e) A screw is provided in the Locking Lever to prevent accidental removal when mounted on an open bracket. Use a Phillips screwdriver to tighten the screw snug. Do not over tighten.





CONNECTING EPIC 3 *BLUETOOTH* LSM TO A PORTABLE TWO-WAY RADIO

The following instructions apply to the use of a *BLUETOOTH* LSM assembly with an approved portable two-way radio. All cords must be positioned such that they do not interfere with the function of the respirator or present a safety hazard to the user.

- 1. Attach the radio connector from the *BLUETOOTH* LSM to the portable two-way radio according to the instructions provided with the two-way portable radio.
- 2. The user must place the radio on his person so that the radio is protected and securely attached. There must not be excessive slack in the cord from the push-to-talk button to the radio which could present a hazard of snagging.
- 3. Position *BLUETOOTH* LSM assembly where it will be readily accessible. Secure the cord to the two-way portable radio.
- 4. If the *BLUETOOTH* LSM assembly is being used with a two-way portable radio in a fire fighting application, two-way portable radio and radio cable must be contained within the fire fighter's turnout gear for protection from heat and flame.

USE OF THE EPIC 3 RI COMMUNICATION ASSEMBLY WITH A TWO-WAY PORTABLE RADIO

Before the RI VOICE AMP assembly may be used with the *BLUETOOTH* LSM assembly, the two units must paired. If the initial pairing of the two devices has not been completed return to PAIRING THE EPIC 3 RI VOICE AMP WITH THE EPIC 3 *BLUETOOTH* LSM section of this instruction

Before use, the user must understand the limitations of the portable two-way radio, especially any limitations on use in an explosive or flammable atmosphere. The user must also inspect and test the portable two-way radio in accordance with the radio manufacturer's operating manual for the portable two-way radio being utilized.

Verify that the radio specific connector at the end of the cord from the *BLUETOOTH* LSM assembly has been properly attached to the two-way portable radio.

To use the RI COMMUNICATION assemblies attached to a portable two-way radio proceed as follows:

- 1. <u>First</u>, turn ON the RI VOICE AMP by pressing the POWER button for approximately one (1) second.
- 2. <u>Second</u>, turn ON the portable two-way radio connected to the *BLUE*-*TOOTH* LSM according to the instructions provided with the two-way portable radio. The LED light on the front of the housing will briefly flash Green to indicate the unit is ON. The two-way portable radio must be ON for the system to operate.

If the radio is turned ON prior to turning on the RI VOICE AMP, the BLUETOOTH radio will need to be reactivated. Either turn the radio OFF and then back ON <u>OR</u> triple click the PPT on the *BLUETOOTH* LSM.

- 3. After a few moments, both LED lights will start blinking GREEN to indicate both units are searching for a paired device for connection. Both will turn a solid GREEN once they have connected and RI VOICE AMP will emit an audible tone. While searching for a connection, both LED lights will blink GREEN for one (1) minute. If an connection has still not been established, both LED lights will blink ORANGE for an additional thirty (30) seconds. If the RI VOICE AMP LED turns a solid ORANGE or the *BLUETOOTH* LSM LED turns OFF, the RI VOICE AMP and the *BLUETOOTH* LSM are not properly paired. Return to the PAIRING THE EPIC 3 RI VOICE AMP WITH THE EPIC 3 *BLUETOOTH* LSM section of this instruction and verify that the two units are paired. If you cannot successfully connect the two units, remove them from service and tag for repair or replacement.
- 4. Test the operation of the RI VOICE AMP assembly by pressing the pushto-talk button on the *BLUETOOTH* LSM to activate the send function of the portable radio. Talking into the RI VOICE AMP facepiece assembly should result in voice communications through the portable radio. If the unit does not operate properly, remove the unit from service and tag for repair or replacement.
- 5. Adjust the speaker volume of the facepiece assembly by using the volume control on the portable two-way radio.
- To transmit a message over the portable twoway radio, press the push-to-talk button on the side of the *BLUETOOTH* LSM housing. When connected to a portable radio, pressing this button will activate the push-to-talk function of the radio.

NOTE

IN-COMING MESSAGES ON THE TWO-WAY PORTABLE RADIO WILL STILL BE HEARD WHEN THE RI VOICE AMP IS IN USE.

- 7. The Belt Clip on the back of the *BLUETOOTH* LSM rotates for attachment. There are eight (8) detents to hold the selected position.
- 8. Certain *BLUETOOTH* LSM models are equipped with a RED Emergency Button to activate that feature on compatible portable radios. Refer to the user manual for your portable two-way radio for details of use. If the RED Emergency Button is not installed on your unit, that feature is not available.

USE OF THE EPIC 3 *BLUETOOTH* LSM AS A LAPEL MIC WITH A TWO-WAY PORTABLE RADIO

The *BLUETOOTH* LSM may be used alone as LAPEL SPEAKER MIC with a portable two-way radio.

- 1. Connect the two-way radio to the lapel speaker mic. See CONNECTING BLUETOOTH LSM TO A PORTABLE TWO-WAY RADIO.
- 2. Turn ON the portable two-way radio according to the instructions provided with the radio. The LED on the *BLUETOOTH* LSM will briefly turn GREEN, then start to blink GREEN as it searches for a paired RI VOICE AMP. When a paired voice amplifier is not found or it has not previously been paired to a voice amplifier, it will turn off the LED to conserve power.
- 3. Press the push-to-talk button on the side of the *BLUETOOTH* LSM and speak into the *BLUETOOTH* LSM to transmit a message.

TERMINATION OF USE

Exit from the area requiring respiratory protection. After leaving the contaminated area and arriving in a safe, clean atmosphere, decontaminate as required by your respiratory protection program. Remove any encapsulating protective garments. Remove the respirator following the instructions for the SCOTT respirator you are using.

- 1. Turn OFF the RI VOICE AMP by pressing the ON/OFF button located on the top of the facepiece assembly and holding for three (3) seconds.

- 3. Once the portable two-way radio is turned OFF, the *BLUETOOTH* LSM will turn OFF automatically.
- 4. Remove the RI VOICE AMP facepiece assembly as follows:
 - a) Loosen facepiece retention screw, if engaged.
 - b) Press the locking spring lever outward (away from facepiece).
 - c) With locking lever disengaged, rotate the facepiece assembly one quarter turn clockwise (as viewed from the right hand exterior of the facepiece) and lift the assembly away from the facepiece.



REMOVING RI VOICE AMP ASSEMBLY

EMERGENCY OPERATION

If the RI VOICE AMP assembly becomes separated from the facepiece and is lost, the *BLUETOOTH* LSM will not operate as a Lapel Mic until the pairing link is broken. To break the pairing link, press the push-to-talk button on the side of the *BLUETOOTH* LSM housing three (3) times within three (3) seconds. This will break the pairing link to the RI VOICE AMP assembly and immediately permit normal use of the *BLUETOOTH* LSM as a Lapel Mic with the attached portable two-way radio. To indicate that the pairing link has been broken, the LED on the *BLUETOOTH* LSM will change to fast blinking GREEN. Press the push-to-talk button on the side of the *BLUETOOTH* LSM and speak into the *BLUETOOTH* LSM to transmit a message.

If the RI VOICE AMP assembly is found after breaking link, and is still ON, you may restore the pairing link. Press the push-to-talk button on the side of the *BLUETOOTH* LSM housing three (3) times within three (3) seconds. When the link is restored, both LED's will be solid GREEN.

If the link is not restored by this method, turn OFF both the RI VOICE AMP assembly and the portable two-way radio and then turn them ON again. This should restore the paring link.

If the link is still not restored, return to the PAIRING THE RI VOICE AMP WITH THE *BLUETOOTH* LSM section of this instruction and pair the units again. If pairing cannot be achieved, remove the units from service and tag for repair.



ACCESSORIES FOR THE EPIC 3 BLUETOOTH LSM

CONNECTING THE ACCESSORIES TO THE EPIC 3 BLUETOOTH LSM

All accessories attach to the *BLUETOOTH* LSM cable using the same type of connector.



To connect accessories to the BLUETOOTH LSM:

- 1. Remove the cap from the end of the BLUETOOTH LSM cable.
- 2. Align the locking groove on the sleeve of the accessory cable with the locking post on the *BLUETOOTH* LSM cable and push together.

NOTE

WHEN PROPERLY ALIGNED, THE LOCKING POST WILL SLIDE EASILY INTO LOCKING GROOVE. THE ACCESSORY CABLE IS KEYED TO CONNECT TO THE *BLUETOOTH* LSM CABLE ONLY ONE WAY. DO NOT FORCE. IF UNABLE TO CONNECT TURN THE ACCESSORY CABLE 180 DEGREES AND RETRY.

- 3. Twist the sleeve to lock the post in place. An audible click will indicate that the locking post is in place.
- 4. Test the connection.

To disconnect accessories from the BLUETOOTH LSM:

- 1. Twist the sleeve so the locking groove and locking post are aligned; then pull apart.
- 2. Replace the cable cap.

The Push-To-Talk Ring can be actuated when worn on finger under an encapsulating protective glove. When installed, the Push-To-Talk Ring operates the same as the Push-To-Talk Button on the side of the *BLUETOOTH* LSM assembly.

The Push-to-Talk Ring accessory is not intended for use in applications which may cause exposure to high heat or flame. If the accessory is being used with a two-way portable radio in a fire fighting application, the two-way portable radio, cables, and the accessory must be contained within the fire fighter's turnout gear for protection from heat and flame.

Install and use as follows:

- 1. Connect the Push-To-Talk Ring cable to the *BLUETOOTH* LSM according to the CONNECTING THE ACCESSORIES TO THE EPIC 3 *BLUETOOTH* LSM section of this instruction.
- 2. Turn on the portable two-way radio and verify that the Push-To-Talk Ring is operating properly. When connected properly, pressing this ring will activate the Push-To-Talk function of the radio.
- 3. Position the Push-To-Talk Ring where it can be easily actuated with the other safety equipment worn.
- 4. Secure Push-To-Talk Ring in place using the Velcro straps

PUSH-TO-TALK PADDLE

Optional Push-To-Talk Paddle accessory SCOTT P/N 201227-01. This Push-To-Talk Paddle can be actuated when worn under an encapsulating protective garment. When installed, the Push-To-Talk Paddle operates the same as the button on the side of the *BLUETOOTH* LSM assembly.

The Push-to-Talk Paddle accessory is not intended for use in applications which may cause exposure to high heat or flame. If the accessory is being used with a two-way portable radio in a fire fighting application, the two-way portable radio, cables, and the accessory must be contained within the fire fighter's turnout gear for protection from heat and flame.

Install and use as follows:

- 1. Connect the Push-To-Talk Paddle cable to the *BLUETOOTH* LSM according to the CONNECTING THE ACCESSORIES TO THE EPIC 3 *BLUETOOTH* LSM section of this instruction.
- Turn on the portable two-way radio and verify that the Push-To-Talk Paddle is operating properly. When connected properly, pressing this button will activate the Push-To-Talk function of the radio.
- 3. Position the Push-To-Talk Paddle where it can be easily actuated with the other safety equipment worn.
- After donning, secure the cord from the Push-To-Talk Paddle so that it will not present a hazard of snagging while

in use. The cord must be positioned so that it is not excessively loose or excessively tight and does not pull on the *BLUETOOTH* LSM.

If the unit does not operate properly, remove the unit from service and tag for repair or replacement.

Optional Command Comms Headset SCOTT P/N 201229-01. The Command Comms Headset is designed for two-way radio communication with a two-way portable radio. This Command Comms Headset includes an earpiece speaker and a microphone with adjustable arm. When connected to the radio, the headset will disable the radio speaker and microphone and route all communication directly into the headset speaker and microphone. The Command Comms Headset microphone operates using the Push-To-Talk Button on the side of the *BLUETOOTH* LSM assembly.

The Command Comms Headset is not intended for use in applications such as fire fighting which may cause exposure to high heat or flame. If the accessory is being used with a two-way portable radio in a fire fighting application, the two-way portable radio, cables, and the accessory must be contained within the fire fighter's turnout gear for protection from heat and flame.

Install and use as follows:


1. Turn off radio before installing the Command Comms Headset.

NOTE

INSTALLATION OF THE HEADSET WHILE THE RADIO IS ON MAY CAUSE THE RADIO TO TRANSMIT CONSTANTLY, LOCKING UP YOUR RADIO SYSTEM. IF THIS SHOULD HAPPEN, TURN OFF THE RADIO. THE RADIO CAN THEN BE TURNED BACK ON, RESTORING NORMAL OPERATIONS.

- 2. Connect the Command Comms Headset cable to the *BLUETOOTH* LSM according to the CONNECTING THE ACCESSORIES TO THE EPIC 3 *BLUETOOTH* LSM section of this instruction.
- 3. Place the Command Comms Headset around the back of the head with both earpieces resting over the top of the ears. The speaker should be positioned directly over the left ear. Adjust the microphone arm so that the microphone is situated 1/2" or less from the mouth.
- 4. Turn on the portable two-way radio and verify that the headset is operating properly. Speak into the headset microphone while pressing the Push-To-Talk button on the *BLUETOOTH* LSM to transmit a message through the portable radio.
- Secure the cord from the Command Comms Headset so that it will not present a hazard of snagging while in use. The cord must be positioned so that it is not excessively loose or excessively tight and does not pull on the *BLUETOOTH* LSM assembly any way.

If the unit does not operate properly, remove the unit from service and tag for repair or replacement.

COMMAND THROAT MIC KIT


Optional Command Throat Mic Kit SCOTT P/N 201228-01 is designed for two-way radio communication with a two-way portable radio. This kit includes an adjustable Command Throat Mic with magnetic fastener, an Ear Bud, and a Push-To-Talk Ring. When worn around the neck the Command Throat Mic is designed to pick up and transmit the vibration directly from your vocal cords. This assembly will disable the radio speaker and microphone and route all outgoing communication directly from the Throat Mic to the radio and all incoming communication back from the radio into the earbud.

The Command Throat Mic Kit accessory is not intended for use in applications which may cause exposure to high heat or flame. If the accessory is being used with a two-way portable radio in a fire fighting application, the two-way portable radio, cables, and the accessory must be contained within the fire fighter's turnout gear for protection from heat and flame.

Install as follows:

- 1. Turn off radio before installing the Command Throat Mic Kit.
- 2. Assemble the Command Throat Mic Kit.
 - Plug the cable from the Connector to the BLUETOOTH LSM according to the CONNECTING THE ACCESSORIES TO THE EPIC 3 BLUETOOTH LSM section of this instruction.
 - (B) Plug the cable from the Push-To-Talk Ring into the Connector.
 - C Plug the Lapel Clip into the Throat Mic.
 - D Plug the Earbud into the Lapel Clip and turn counterclockwise to lock.
- 3. Place Throat Mic around neck with the microphone disc centered in front. Adjust the straps to hold the Throat Mic securely in place without obstructing normal breathing. Secure with the magnetic fastener.
- 4. Place Earbud comfortably in ear and attach Lapel Clip to keep in place.
- 5. Turn on the portable two-way radio and verify that the Throat Mic is operating properly. Speak in a normal voice while pressing the Push-To-Talk button on the Push-To-Talk Ring to transmit a message through the portable radio.
- 6. Secure the cord from the Command Throat Mic so that it will not present a hazard of snagging while in use. The cord must be positioned so that it is not excessively loose or excessively tight and does not pull on the *BLUETOOTH* LSM assembly any way.

If the unit does not operate properly, remove the unit from service and tag for repair or replacement.



COMMAND THROAT MIC KIT

CLEANING AND INSPECTION

CLEANING

- 1. After use, the components of COMMUNICATION ASSEMBLIES may be cleaned with a damp sponge. A solution of water and mild dish detergent may be used if necessary.
- Take care prevent excessive amounts of water from entering the holes for the speaker or the microphone. DO NOT IMMERSE EITHER THE FACE-PIECE ASSEMBLY OR THE BLUETOOTH LSM ASSEMBLY IN LIQUID.

INSPECTION

After each use, inspect the COMMUNICATION ASSEMBLIES for damage. If any damage is found, remove the equipment from service and tag for repair by authorized personnel. No attempt to disassemble or repair the COMMUNICATION ASSEMBLIES shall be made.

- 1. Inspect the housings of the Facepiece Assembly and *BLUETOOTH* LSM for cracks or other damage that could interfere with the usability of the equipment.
- 2. Check for missing components.
- 3. Inspect the cables from the *BLUETOOTH* LSM assembly for cuts, corrosion, or other damage. If any damage to the cable is found, remove the unit from service and tag for replacement. DO NOT USE A UNIT WITH A DAMAGED CABLE.
- 4. Turn the units ON and check for the LOW BATTERY ALERT. If the LED on the Facepiece Assembly or the *BLUETOOTH* LSM is flashing RED, the batteries are low. Refer to BATTERY INSTALLATION section of this instruction for Battery replacement. Be sure to turn the units OFF before storing.
- 5. Unused accessory connector must be capped when not in use.

WARNING

BATTERY DOOR ASSEMBLY

To replace the battery door assembly SCOTT P/N 201079-01.

- 1. Remove retaining screw from battery cover and discard.
- 2. Remove the screw from the existing battery door hinge. Set screw aside for later use.
- 3. Remove the existing battery door and discard.
- Apply a thin film of Parker Super-O-Lube¹ lubricant to the new battery door gasket and install it on the new battery door.
- Place the new battery door in position between the two outside walls of the door hinge and secure with saved hinge screw.

If only the gasket around the inside of the battery door is damaged or missing, replace with SCOTT P/N 10009051.

- 1. Be sure the old gasket is completely removed and the groove for the seal gasket is clean before installing the new gasket.
- 2. Apply a thin film of Parker Super-O-Lube lubricant to the battery cover gasket before installing it on the battery cover.

- 1. Remove the spring lever locking screw (C) with #1 Phillips screw driver.


BATTERY DOOR REPLACEMENT

If the EPIC 3 *BLUETOOTH* LSM battery door is damaged, replace with SCOTT P/N 31001098.

This includes a battery door with two captive screws installed and a new hinge pin. It does not include a new belt clip. Refer to the BELT CLIP REPLACEMENT section of this instruction for details.

To replace the battery door with SCOTT P/N 31001098, proceed as follows:

- 1. Support the *BLUETOOTH* LSM assembly. Use a 1/16" (1.5 mm) drive punch to drive the pin out. The pin is press fit in only one side of the hinge.
- 2. Inspect the hinge on the *BLUETOOTH* LSM housing for damage such as cracks. If any damage is found, remove the unit from service and tag for replacement.

- 3. Place the new Battery Door in position and drop the new pin though the holes in the hinge on the door and the housing.
- 4. Carefully tap the hinge pin into the press fit side of the hinge until it fits flush on both ends.
- 5. Inspect the *BLUETOOTH* LSM to verify that the battery door closes properly. If any problems are observed, remove the unit from service and tag for return to SCOTT or your SCOTT distributor.


- Carefully remove the old gasket. Do not scratch or damage the gasket channel while removing.
- 2. If necessary, remove any dirt or debris from the gasket channel using a small brush such as an old tooth brush.
- 3. The gasket has a "flat" side and a "tapered" side. With the flat side **down**, carefully fit the new gasket into the gasket channel.
- 4. Be sure the gasket is fitted evenly around the battery compartment opening.
- 5. Inspect the *BLUETOOTH* LSM assembly to verify that the battery door closes properly. If any problems are observed, remove the unit from service and tag for return to SCOTT or your SCOTT distributor.

BELT CLIP REPLACEMENT

- Two Belt Clip styles are available for the EPIC 3 *BLUETOOTH* LSM assembly. Replacement screws can be ordered separately.
 - Clothes Pin Belt Clip SCOTT P/N 31003083 (standard)
 - Alligator Belt Clip SCOTT P/N 31003082
 - Screw #4-40 X 3/16 P/N 31002867

If the belt clip is damaged or missing, replace as follows:

- Remove the four (4) screws holding the belt clip on battery door. Put aside for installation of new belt clip.
- 2. If necessary, remove any dirt or debris from back of battery door.
- Install new belt clip using the four (4) screws removed in Step 1. Tighten until snug. DO NOT OVER-TIGHTEN.
- 4. Verify that new belt clip rotates properly and clips into position.
- 5. Inspect the *BLUETOOTH* LSM assembly to verify that the battery door closes properly with the belt clip installed. If any problems are observed, remove the unit from service and tag for return to SCOTT or your SCOTT distributor.
