## **Owner's Manual Use Case**

NFC technology will allow customers to pair their mobile devices to the vehicle infotainment system (over Bluetooth) by just holding their device near the Integrated Center Stack Display.

"Mobile device" refers to any device that supports both Bluetooth and the full NFC specification. This means it could include a phone, tablet or NFC tag, e.g. the Nexus 10. Some smart phones (e.g. iPhone 6) will not support the feature because they do not support the full NFC specification.

There is a target with a special NFC logo that directs the customer where to hold the phone/tablet/NFC tag. The mobile device can be up to 4cm away. In practice, this means about an inch away from the Instrument Panel.

NFC capability needs to be enabled on the device. Other than that, it depends on the device, but for devices we are aware of, the device does not need to be on a specific screen or anything to perform the "tap" and start the pairing process, but the device will then pop a message up for the user to confirm in order for the process to be completed.

	<p>Data transmission is always initiated by software, which is then passed down through the MAC, through the digital and analog baseband, and finally to the RF chip. Several special packets are initiated by the MAC. These are the only ways the digital baseband portion will turn on the RF transmitter, which it then turns off at the end of the packet. Therefore, the transmitter will be on only while one of the aforementioned packets is being transmitted. In other words, this device automatically discontinues transmission in case of either absence of information to transmit or operational failure.</p> <p>La transmission des données est toujours initiée par le logiciel, puis les données sont transmises par l'intermédiaire du MAC, par la bande de base numérique et analogique et, enfin, à la puce RF.
