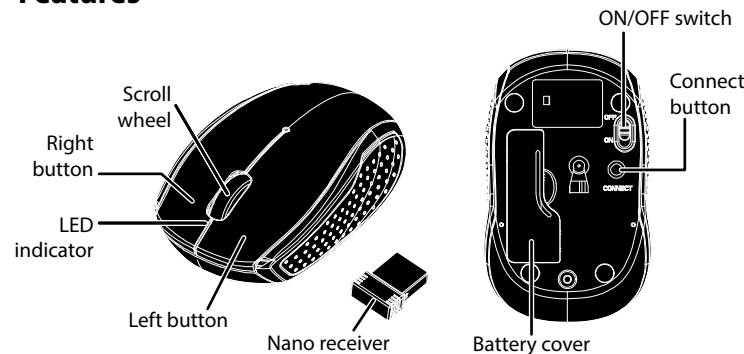

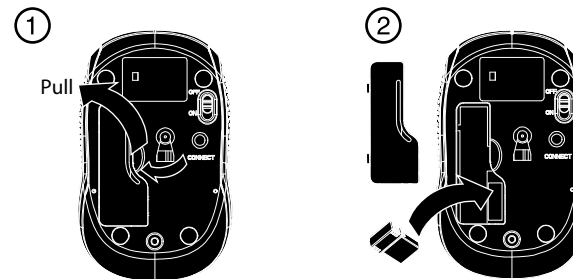

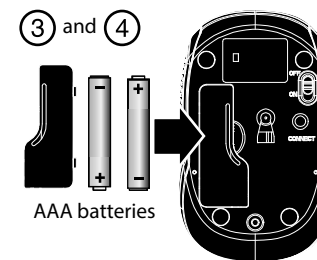
### Installing the mouse batteries and removing the nano receiver

- 1 Take the battery cover off.
- 2 Remove the nano receiver.

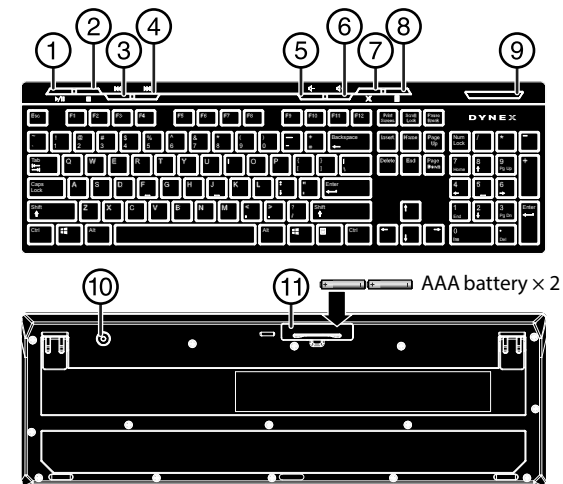


- 3 Insert the batteries as shown inside the battery compartment.
- 4 Replace the cover.

**Caution:** Insert the battery with the correct orientation, according to the instruction label on the mouse.



### Keyboard buttons Media player hot keys



#	Icon	Function	Description
1	▶/	Play/Pause	Switch between playing and pausing media.
2	■	Stop (Media)	Stop playing the media in the media player.
3	◀◀	Previous	Switch to the previous media track.
4	▶▶	Next	Switch to the next media track.
5	◀-	Volume down (Voice-)	Decrease the computer's sound volume.
6	▶+	Volume up (Voice+)	Increase the computer's sound volume.
7	✖	Mute	Mute (turns off) the computer's sound.
8	☰	Calculator	Start Microsoft calculator.
9	LED indicator		Low battery and pairing indicator.
10	Connect button		Press to initiate pairing with your computer.
11	Battery cover		Remove to install or replace the batteries.

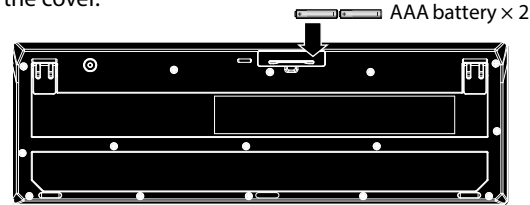

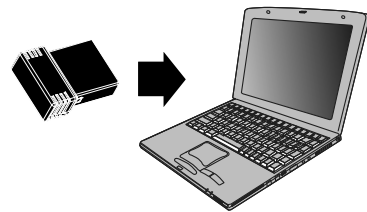
### Installing the keyboard batteries

- 1 Take the battery cover off.
- 2 Insert the batteries as shown inside the battery compartment.
- 3 Replace the cover.



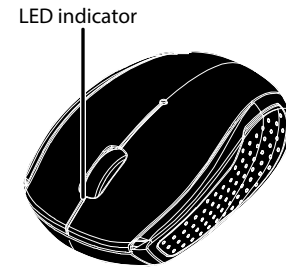
### Setting up the connection between the nano receiver, mouse and keyboard

- 1 Plug the nano receiver into the USB port on your computer.



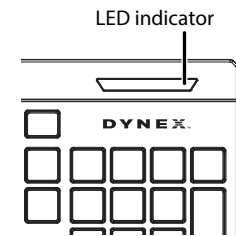
- 2 If the mouse or keyboard does not work, do the following:  
Re-plug the nano receiver into the USB port on your computer, then press the connect button on the mouse and keyboard. If the mouse or keyboard does not work after 10 seconds, pair them again by pressing the connect button on the mouse or keyboard. (The receiver has auto-pairing function).
- 3 The LED indicator on the mouse and keyboard flashes steadily when it is in pairing mode and stops blinking when it is successfully paired with the receiver.
- 4 When the battery gets low, the battery indicator on the mouse or keyboard will start to blink.

### Mouse indicator



Power ON	Red LED is on for 10 sec.
Low battery warning	Red LED blinks for 10 sec.
Pairing	Red LED blinks.
When paired or failed after 10 sec.	LED is off.

### Keyboard indicator



Power ON	Red LED is on for 10 sec.
Low battery warning	Red LED blinks for 10 sec.
Pairing	Red LED blinks.
When paired or failed after 10 sec.	LED is off.

### Cleaning your mouse and keyboard

- Wipe the mouse and keyboard with a damp, lint-free cloth.

### Troubleshooting

- Make sure that your computer meets the system requirements.
- Only use the mouse on a clean, flat, non-slippery surface to ensure smooth and accurate cursor action.
- Avoid using your mouse on reflective, transparent, or metallic surfaces.
- If your mouse or keyboard stops working:
  - Make sure your mouse or keyboard and nano receiver are paired by pressing the connect button on the mouse or keyboard.
  - Replace the mouse or keyboard batteries.
