






## Connecting the mouse

- 1 Remove the **wireless signal receiver** from the bottom of the mouse and insert it into a **USB port** on the computer.



- 2 Set the **power switch** at the bottom of the mouse to the **ON** position.
- 3 The wireless mouse connection has been completed.



If the mouse does not work, separate and reconnect the wireless receiver, and press the Connect button on the mouse within 30 seconds.
