It also offers more configuration options.

We offer the Wireless LAN Configuration Utility for Windows® 98SE/Me/2000/XP. Mini-PCI WLAN equipment has been tested and found to comply with limits for a Class B digital device, pursuant to Part 15 of the FCC rules. These limits are designed to provide reasonable protection against harmful interference in residential installations.

Install the WLAN card

- Release the screw from PC/NB
- Find out the pre-wired cable
- Connect the cable with Mini-PCI ("Main" connector)
- Align and firmly plug the Mini-PCI card into the slot.
- Re-place the cover to Device Secure the screw with a cross screwdriver.


