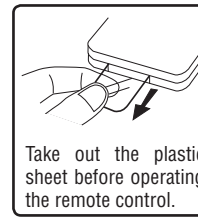
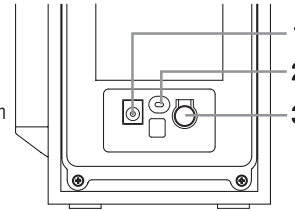
## Soundbar

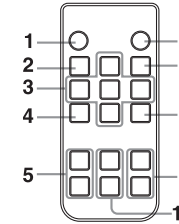

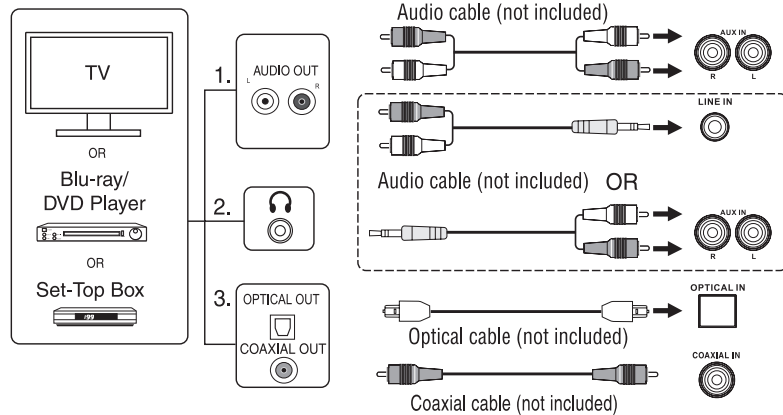
## Remote Control

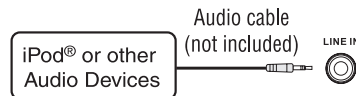
Press once to select OPTICAL IN, press again to select COAXIAL IN.

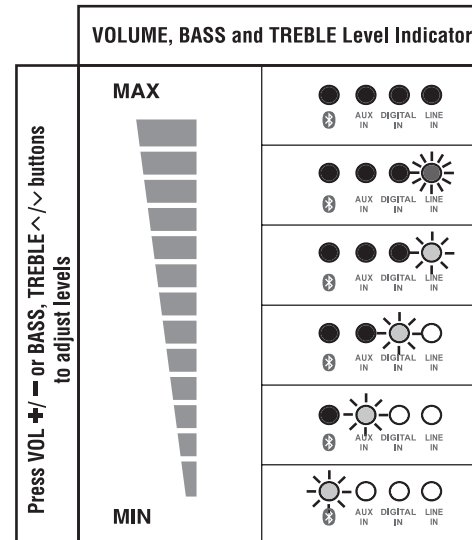
## Play audio through Bluetooth:

1. Press SOURCE button on the unit or button on the remote control to select BT (Bluetooth) mode. The Bluetooth indicator light on the soundbar will blink.
2. On your device (mobile phone, MP3 player, etc.), select "Bluetooth" from the list of available Bluetooth connections.

Note: If your Bluetooth device (such as, mobile phone) requires a password while pairing, please enter 4-digit number: 0000.

- If the Bluetooth pairing is successful, the Bluetooth indicator will illuminate.
- If the Bluetooth pairing is unsuccessful, the Bluetooth indicator will blink at slow speed. Please try again.

## Pairing the Soundbar with the Wireless Subwoofer

1. Connect the AC adaptors to the soundbar and wireless subwoofer respectively.
2. Turn on the Soundbar by pressing the **I/O** Standby/ON button.
3. The subwoofer will pair up with the soundbar automatically. The pairing indicator stops flashing when it is complete and successful.
