## Base Unit 3000 Buttons



**Answer:** To answer a call, pick up the handset and press the **Answer** button.

**Hang Up:** When the call is complete, press the **Hang Up** button.

**Call:** To call the Dialout Number, which can be found in the Device Parameters, press the **Call** button.

**911:** In case of emergency, the Base Unit 3000 can dial 9-1-1. To dial 9-1-1, press and hold the Hang Up and Call buttons until all LEDs blink red.

### Instructions concerning human exposure to radio frequency electromagnetic fields.
