Unpack the box

Check the components

Your tablet comes with:


- AC adaptor (2-pin or 3-pin)
- Micro-USB cable
- Stylus pen (provided with some models)
- Several documents, including Instruction Manual for Safety and Comfort.
- It may also ship with documentation for other software that may be pre-installed on your tablet. Some software may differ from its retail version (if available), and may not include user manuals or all program functionality.

If any of the items are missing or damaged, contact your dealer immediately.

Charging your tablet

Your tablet contains a rechargeable battery that may need to be charged prior to use.

 Plug the USB connector of the Micro-USB cable into the AC adaptor and the other smaller connector into the Micro-USB port on your tablet.





Depending on the model, either a 2-pin or 3-pin AC adaptor will be bundled with the tablet.




The Micro-USB connector of the Micro-USB cable must be correctly plugged into the Micro-USB port on the tablet. Failure to do so correctly may result in possible damage to the Micro-USB port.

Plug the AC adaptor into a wall outlet.

Task View

Task view ([]]) is launched from Windows taskbar at the bottom of the screen. You can view the apps that are currently running by tapping the Task view ([]]) icon.

Search

Search on the Windows taskbar allows you to find apps, files, settings, and more on the computer. When Internet connection is available, it also shows you the best search result from the Internet. The personal assistant called **Cortana** might be available depending on your country/region. You can ask questions or talk to Cortana in natural voice, and Cortana answers your questions using information from the Internet. To use Cortana, an internal or external microphone is required.

Action center

You can review important notifications from apps or Windows in action center, and take action without having to open apps. It also provides quick action buttons to access to most-used settings instantly.

Select the action center icon 👨 on the Windows taskbar to view your notifications and quick actions.

Settings

Settings provides system settings including advanced settings in the Control Panel. They are divided in categories so that you can configure, optimize, or personalize Windows.

You can also type in the keyword, use **Search** to find any setting.

To open Settings, tap the = icon on the Main screen and select **Settings** (👸).

You can pin it to the Start menu as a tile by pressing and holding on Settings and selecting Pin to Start.

Windows Store

Although many applications are pre-installed in your tablet, you can also download many others from the Windows Store.

You can search for and browse thousands of apps, all grouped into easy-to-find categories there.

Sign-in options

Windows offers a number of sign-in options including **Password** (\bigcirc), **PIN** ($\stackrel{\blacksquare}{\longrightarrow}$) and **Picture password** (\bigcirc) authentication to prevent from unauthorized access. If you have multiple sign-in methods set for a user account, you can select an option on the Windows login screen by tapping sign-in options. Password authentication is the default sign-in option.

Turning on/off

To turn on the tablet, press and hold the **Power** button for several seconds. When your tablet is on, press the **Power** button to put it into sleep mode or wake it up.

To turn off the tablet, you can use either of the following way:

■ Tap the Power (()) icon on the Main screen and then select Shut down.



The tablet can not be powered on by pressing the power button if the battery power is completely exhausted. It is recommended to charge the battery pack by connecting the AC adaptor for 30 minutes before turning on the power.

Creating Recovery Media

It is strongly recommended that you create recovery media before using your tablet for the first time. This will enable you to return your system to its out-of-box state.

A recovery image of the software on your tablet is stored on the internal storage, and can be copied to a USB Flash Memory by using the following steps:

- 1. Turn on your tablet and allow it to load the Windows operating system as normal.
- Insert the USB Flash Memory into Micro-USB port on your tablet by using the "Micro USB to USB Converter Cable".
- Tap Control Panel -> System and Security -> Security and Maintenance -> Recovery -> Create
 a recovery drive under Windows System group in All apps.
- 4. Follow the on-screen instructions to finish creating the Recovery Media.

Restoring the pre-installed software from the Internal Storage

A portion of the total internal storage space is used to store the recovery image which can be used to restore pre-installed software in the event of a problem.

- 1. Tap the Power (()) icon on the Main screen and then select Shut down.
- After completely shut down the tablet, wait for about 10 seconds. Then hold down the Power button and Volume up button simultaneously until the Boot menu is loaded and then select HDD Recovery.
- 3. Select Troubleshoot.
- 4. Select Reset your PC.
- 5. Follow the on screen instructions to finish the recovery.

You can also perform the restoration through PC settings in the operating system:

- 1. Go to **Settings** and tap **Update & Security -> Recovery**.
- 2. Tap Get started under Reset this PC.
- 3. Follow the on screen instructions to finish the recovery.
