Hardware Installation

Connect the Mouse to Your PC System

1. Turn off your PC system. Remember to turn off your PC system before you connect or disconnect the mouse unless you use a USB device in Windows 98, Windows 2000 or Windows ME.

2. For PS/2 model, you can connect the mouse to the PS/2 port.
3. For the USB model, connect the mouse to the USB port on your PC system.
4. For the Combo (USB-PS/2) model, you will find a USB to PS/2 6-pin adapter is attached. This adapter helps you a lot on solving the USB to PS/2 port issue.
5. Turn on your PC system.
