



## 1. General Description

The F89ETSM13-W2 is a highly integrated single-chip 802.11n Wireless LAN (WLAN) network SDIO interface (SDIO 1.1/ 2.0/ 3.0 compliant) controller. It is a WLAN MAC, a 1T1R capable WLAN baseband, and WLAN RF in a single chip. It provides a complete solution for a high throughput performance integrated wireless LAN device.

## 3. WIFI Specification

### 3.1 WIFI feature

- 3) Enterprise level security supporting: WEP 64bit&128bit, WPA, WPA2, WPA2-PSK and IEEE802.11i;
- 4) IEEE 802.11e QoS Enhancement(WMM);
- 5) Support 1 transmission and 1 receiving, transmission rate can up to 150Mbps (Physical Rate) in downstream and upstream.

When it operating in the 2.4GHz ISM band (2.412-2.462GHz,11 Channels).it support wireless WLAN standards include 802.11b/g/n, communication has 11 channels, whose center frequencies are








### 4.3 Antenna design requirements:

- 2) Antenna is 2.4G WiFi Frequency band MIFA type Board antenna

- 4) PCB thickness is 1.5mm , Copper-Layer 6 , Antenna is Layer1 ;  
5) Antenna put on the edge of the pcb , Clearance around and below ;
