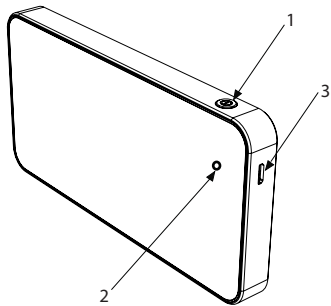

LOCATION OF PARTS AND CONTROLS

1. Power Switch
2. LED Indicator
3. Micro USB Port

CHARGING THE SPEAKER

1. Connect the USB Cable (included) to the Micro USB Port on the speaker.
2. With the speakers Power Switch off, plug the other end of the USB Cable into a USB port on a computer or USB wall adapter (not included)
3. The LED Indicator will illuminate red while charging, and the light will go out when the speaker is fully charged. Charges in approximately 2 hours for up to 5 hours of listening enjoyment.

PAIRING YOUR DEVICE

1. Pairing for the first time
Searching starts automatically after power up. Simultaneously, a tone will sound (the red and blue lights will flash alternately). In your device's Bluetooth menu, search for and select Executive Speaker for pairing.
2. Automatic Pairing
After restarting the unit, it will pair to the last connected device automatically. When pairing is complete, a tone will sound.
3. Re-pairing
To change the connected device, hold down the power button for 1 second to enter pairing mode.

USING THE SPEAKERPHONE

1. Hands-free function when in connection with the phone, short press the power button to pick-up the phone call, short press the power button one more time to hang on the call.

OTHER FUNCTIONS

1. If no devices are found after 6 minutes in searching mode, the speaker will turn off automatically.
2. The speakers battery level will display on your device if it is an iPhone. Alerting you to the remaining charge on the speaker.
