⚠ DANGER – To reduce the risk of electric shock:

9. Do not use the lamp if the electrical outlet is loose.

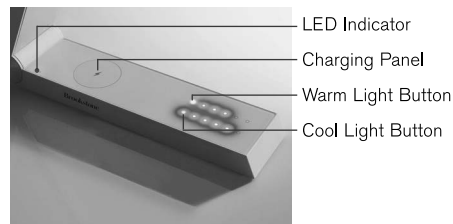
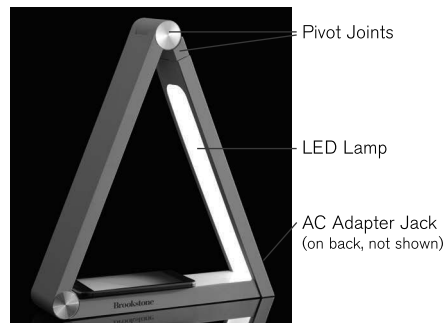

USING THE LIGHT

1. Plug the AC Adapter into the AC Adapter Jack and plug the other end into an electrical outlet. The LED Indicator turns red.
2. Tap the Cool Light button to turn on the light. Tap or swipe the brightness buttons to increase/decrease cool light.
3. Tap the Warm Light button to add warm light. Tap or swipe the brightness buttons to increase/decrease warm light.
4. Tap the Cool button to turn off the light. The current light settings will be retained when the light is next turned on.

CHARGING A DEVICE

With the lamp plugged in, place a device capable of wireless charging (such as a Qi®-compatible device) on the wireless Charging Panel. The LED Indicator will be solid blue while charging. **Be sure to position the device so it is centered on the Charging Panel.**

NOTE: A thick phone case may inhibit charging.

ONE (1) YEAR LIMITED WARRANTY
