

CHARGING THE SPEAKER

- Connect the USB Cable (included) to the Micro USB Port on the speaker.
- With the speakers Power Switch off, plug the other end of the USB Cable into a USB port on a computer or USB wall adapter (not included)
- The LED Indicator will illuminate red while charging, and the light will go out when the speaker is fully charged. Charges in approximately 2 hours for up to 5 hours of listening enjoyment.

PAIRING YOUR DEVICE

- Pairing for the first time
 Searching starts automatically
 after power up. Simultaneously,
 a tone will sound (the red and
 blue lights will flash alternately).
 In your device's Bluetooth menu,
 search for and select pocket
 Speaker for pairing.
- Automatic Pairing After restarting the unit, it will pair to the last connected device automatically. When pairing is complete, a tone will sound.
- Re-pairing
 To change the connected device, hold down the power button for 1 second to enter pairing mode.

USING THE SPEAKERPHONE

 Hands-free function when in connection with the phone, short press the power button to pick-up the phone call, short press the power button one more time to hang on the call.

- If no devices are found after 6 minutes in searching mode, the speaker will turn off automatically.
