Power Saving

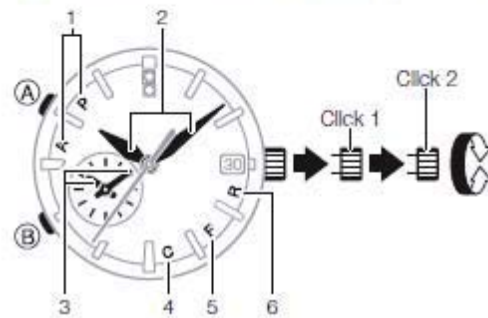
- Leaving the watch in a dark location for about one week will cause all hands to stop at 12 o'clock.

Battery Alerts

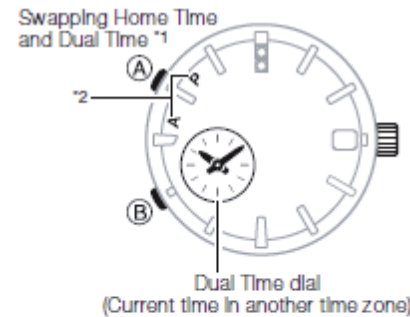
- Low Battery

You can view the current time in your Home City and in one more time zone.



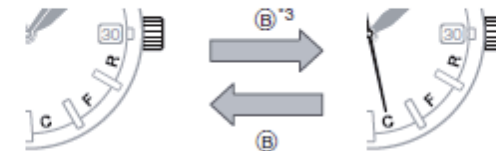
1. Indicate **a.m.** or **p.m.** when setting the Dual Time.

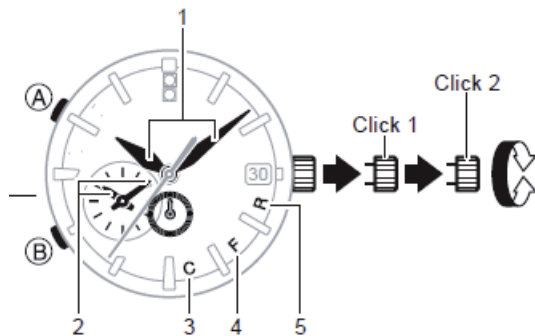

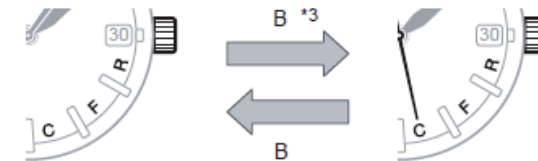
