Gen2IR™ enables certainty-based accuracy at the bed-, bay- and chair-level, rapid location update speeds and extreme battery life. Low Frequency RF supports patient egress and wander prevention while reducing tag loss. This enables hospitals and healthcare administrators to make decisions based on facts about where and when their people and resources are located. The IT-723E tag provides the ability to monitor patients at any time anywhere in a facility. This single tag can be used to track, locate, protect and identify a patient in seconds.

The IT-723E is a battery powered RF/IR Tag that attaches to patients who need to be tracked, located, and identified. Tags may be worn on standard issued medical ID bracelets.
