Besides, RFT500 provides temperature monitoring and take-off detection function helpful to realize the situation of the wearer.

Regarding to the data collision, RFT500 uses two-layer anti-collision technique, significantly reduce the loss rate than general product in the market. Furthermore, friendly and easy setup function is flexible for different application.

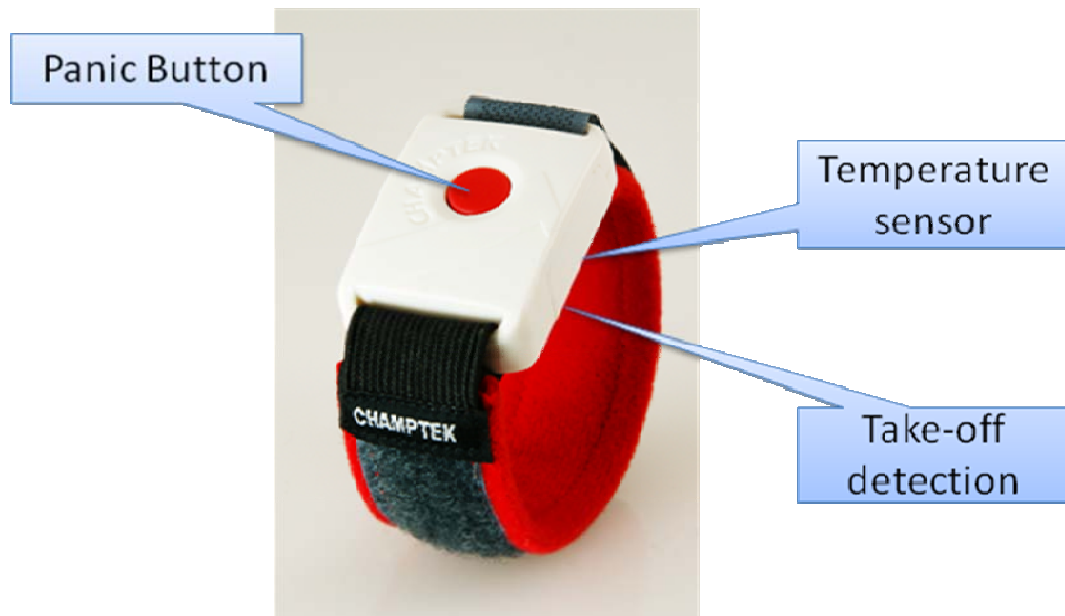

## Mechanicals

### TOP View



Panic Button – Press down will send emergency alarm back to reader.

Temperature sensor – Detect the wrist temperature

Take-off detection – Detect if the wearer takes off the wristband

### Packet Format 1 (without temperature)

### Packet Format 2 (with temperature)

(\*)Status: 0 to 7 means hexadecimal 0x00 to 0x07 (Ex. 0x01 represents the wristband is wearing, battery ok, and key pressed.)

(\*\*) Ex. 322 means 32.2°C

## Implementation Notice

- RFT500 only sends packet with temperature and check battery status once per minute.
- Battery life will decline faster under low temperature environment due to the battery physical characteristic.
