INSTRUCTIONS FOR **S3i HARD TAG** – S3i Hard Tag (S3I-0005)

Key Features:

- Dual EAS technology (AM/RF)
- Includes Lithium battery. Note: Battery is factory replaceable.
- The sound of the alarm emitted is between 90-95 decibels.



Application:



1. Insert the pin through the desired area in the garment; align the pin with the receptacle hole



2. Engage the tag and the pin to lock and arm the tag

Removal:



1. Line the Key Locators on the Key with the Key Locators on the Hard Tag



2. Disengage the Tag from the pin and remove
