- 1. To receive your 3-Year Limited Warranty, purchase a new Panasonic PT-AE8000U home theater projector from an Authorized Panasonic Reseller in the United States from January 1, 2015 – March 31, 2015. This cannot be combined with any other offer.
- 2. Return this completed form, including the serial number label, along with a copy of your invoice with the purchase price circled.
IMPORTANT: You must cut out and include the original label from the carton, which includes the UPC code, model number and serial number, or your registration cannot be processed.
- 3. Offer valid for purchase made from January 1, 2015 – March 31, 2015. All registrations must be postmarked within 30 days of purchase.
- 4. This offer is only available to the end user and original purchaser. No registration from re-sellers, dealers/distributors, their employees or warehouse facilities, groups, clubs or organizations will be accepted or acknowledged.
- 5. Product must be new and un-used. No B-Stock product allowed.
- 6. Offer void where taxed, prohibited or restricted by law. Offer good only in the 50 United States.
