




Handset Battery Charging

- 1. Place handset in base, the CHARGE LED on base will light.
- 2. After batteries are fully charged, check for dial tone by pressing TALK on handset.
- 3. Establish security code by recradling handset for 5 seconds. Handset is now ready to use.
- 4. When handset battery gets low, there will be 2 beeps every 30 seconds. The TALK LED will flash. Return to cradle for charging.

The FF905/FF908 cordless telephone automatically searches and selects the clearest of 40 channels when the handset is picking up from the base. While on a call, if you experience notice or static:

- Press CHANNEL on handset until a clear channel is found; the call will not be interrupted.

Note: You must be in usable range to change channels. Base antenna should be in upright position.

Security Code

The security code prevents your cordless telephone conversation from being accessed by a phone on a different line. Once the handset battery is fully charged, the handset will automatically select the code from a total of over 65,000 combinations. The code is changed every time the handset is placed in the cradle.

If you experience difficulty with placing or receiving calls, a lost security cord may be the cause of the problem. When this occurs, the handsel can no longer communicate with the base. 

The phone does not ring when you receive a call:

- · Make sure the RINGER switch on left side of handset is turned to ON.

- · Make sure you are within usable range of the base
- . You might have too many extension phones on your line. Try unplugging a few.



Noise, static, interference or other calls heard while using handset:




Modular Outlet/Telephone Jacks
