1 Installation

 Install the wireless adapter in your desired location. (See enclosed instructions sheet.)

Note: Each wireless adapter enables you to turn on, turn off, and dim a lighting device up to 15 watts.

2 Download the HALO Home app to your smart mobile device.



3 Create a user account and validate via email

- Enter your email address as your user account name.
- Select a password of at least 8 characters from the mobile application "register" screen.



4. Adding the wireless adapter

- Select "+" on the HALO Home App screen to add the wall plug.*
 - * At least one HALO Home wireless adapter (or compatible device) will need to be installed and powered in order to add it to the HALO Home App device list.



5 Adding the wireless adapter (continued)

- 5a) The app will search for your installed wireless adapter.
- 5b) Select the device and click "Done" to complete the pairing process.

Once the adapter has been successfully claimed, the light that it is connected to it will blink.

* During setup, ensure your HALO Home device is powered and within about 30 feet of your smart mobile device.





Setting up a schedule

To set up a new schedule, follow these steps:

- Once you have claimed a device, select the "

 " icon to the right of your device's name.
- Select the calendar icon on the slider and then select the "+" button.
- · Using the dial, set your desired time.
- Select the days of the week that you want the schedule applied to.
- Select "Save" and give your schedule a unique name.



Creating a group

- At the top left, press the " : " menu icon and select Groups to access the new grouping page.
- Select the "+" in the center of the screen, or in the top right corner, to make your first group. Then enter a unique name for your group and select "Done."
- Touch and drag devices from the bottom of the screen towards the top of the screen to add them to your Group. Repeat to add more and select next
- After your group is saved, you will be brought to the "Group Settings" menu.



Reset to Factory Setting

- Using the wall switch, cycle the power 4 times
 - OFF for 1/2 second and ON for 5 seconds
- The light will flash twice after a successful reset.
- This procedure will unclaim the adapter.

Dimming

• Dimming in the app will match the performance of the light that the wireless adapter is installed within.


