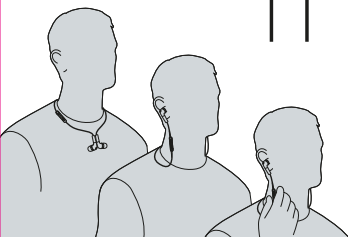
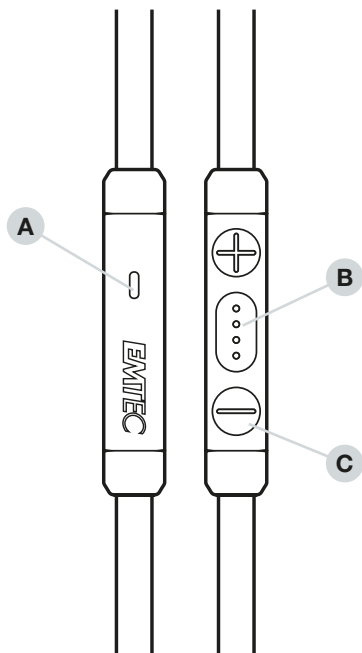

EN Introduction:

This product is a wired headphone speaker. It support connection to Android™ , Windows™ and Apple™ devices (for the iOS version)

For optimal audio quality, your Stay Earbud BT should be used at an ambient temperature of between + 5 °C and + 45 °C (temperate climates). Keep the Stay Earbuds BT away from heat sources such as radiators, candles, lamps, etc.

For your comfort and safety, please read carefully the paragraphs below on recommendations and instructions.

Connect to your smartphone:

Open the bluetooth function of mobile phone, MID and other music players with bluetooth function, and search this device, when you find it, click to connect.

Operating:

- 1) Do not cover the microphone located in **A**
- 2) For iOS compatible version, you can adjust the volume by pressing + or – located in **C**
- 3) You can control the audio functions by pressing the button located in **B** *
 - Once: Play/pause a track
 - Twice: Play next track
 - 3 times: Play previous track
- 4) Controlling the phone function*
 - To accept / end a call, press **B** button
 - To reject a call, press **B** button for 2 seconds
 - To activate Voice control, when the home screen of your Apple model is displayed, press and hold the **B** button for 2 seconds. Say your voice command.
