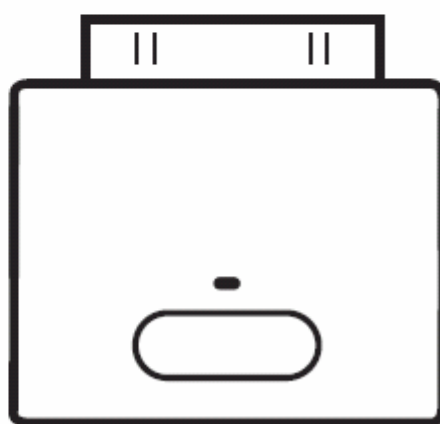

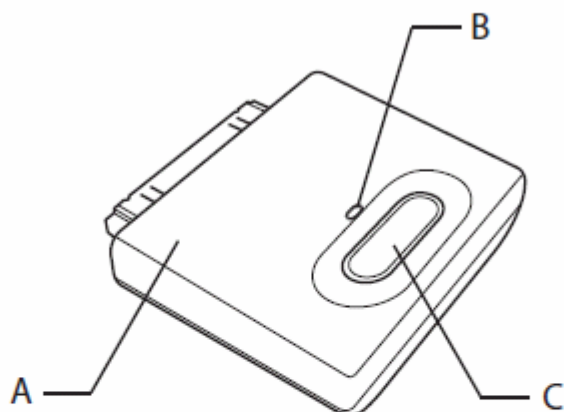

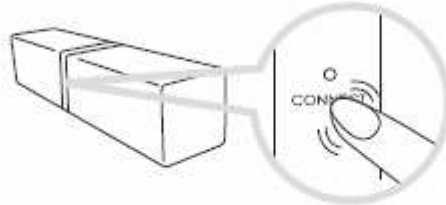

To begin enjoying high performance wireless music on your iPhone and iPod, follow the following steps.

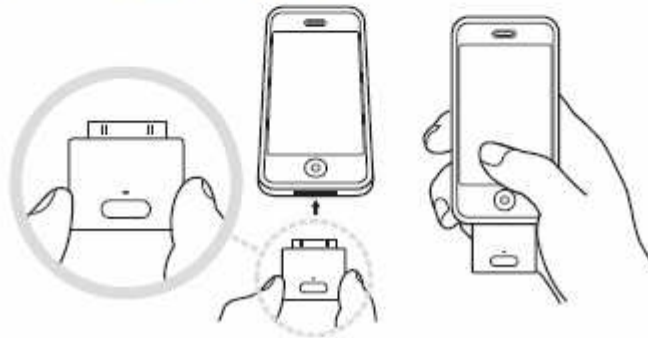
a) Set your respective speaker* / device** into pairing mode



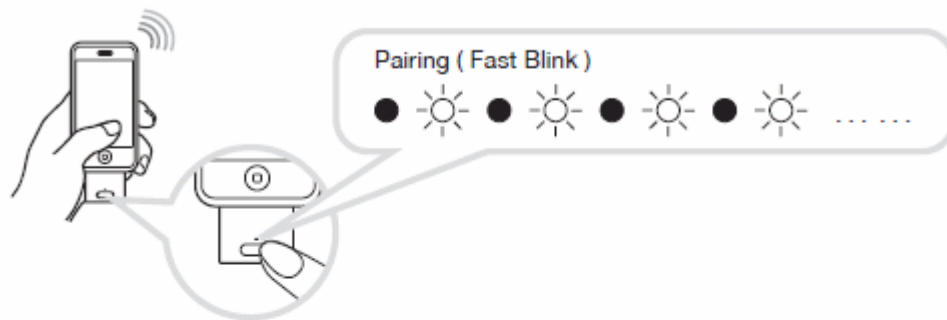

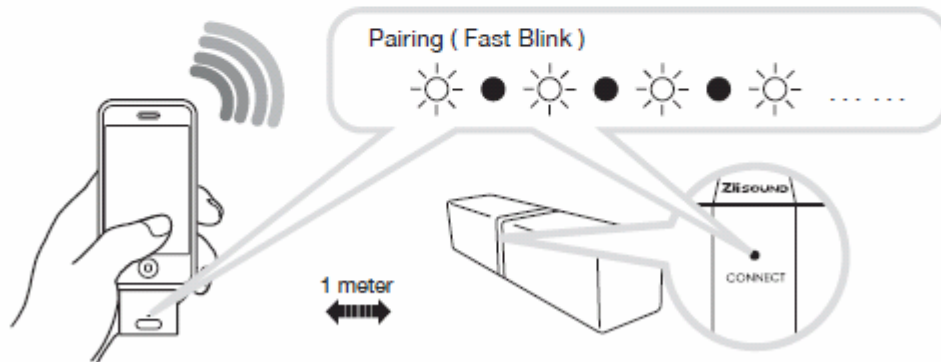
b) Insert the BT-D5 to your iPhone or iPod

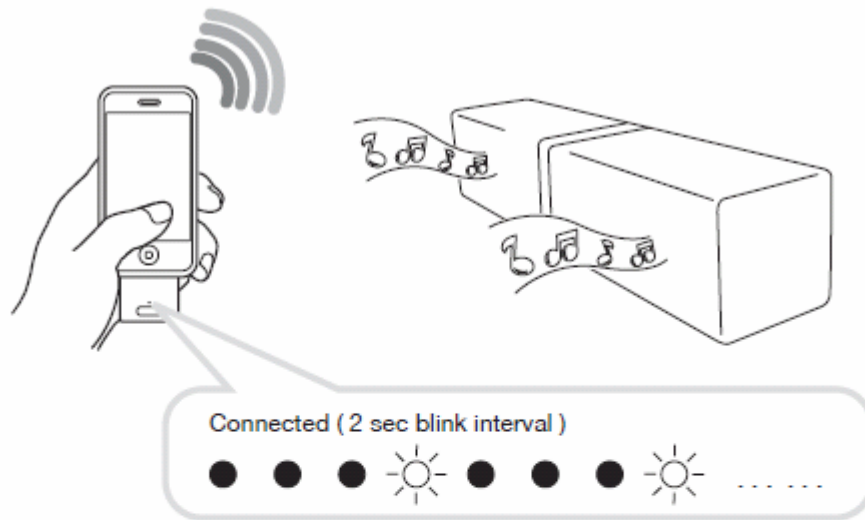


c) Press and hold the CONNECT Button for 3 second, then release to enter pairing mode



d) Put both devices close to each other





To disconnect from the BT-D5

Simply plug out the BT-D5 from your iPhone or iPod

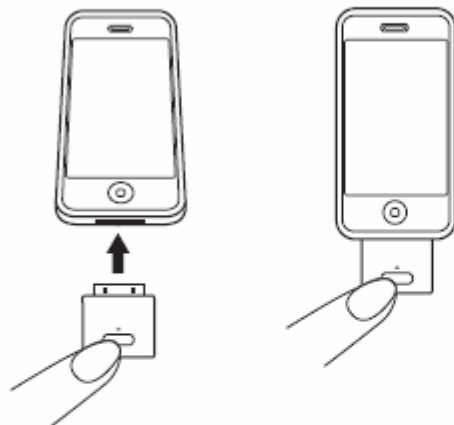
To switch between paired *Bluetooth* devices

Simply press the CONNECT button once with the receiving *Bluetooth* device ready to accept connection.

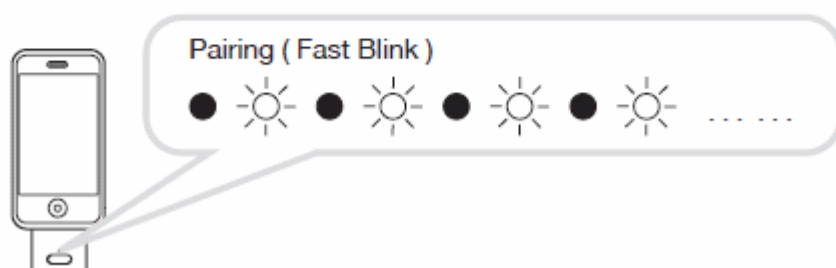
Note: The next receiving *Bluetooth* device should be paired to the BT-D5 prior to the above operation.

To reset the BT-D5 and clear paired device memory

- a) Press and hold the CONNECT button while inserting the BT-D5 into the iPhone or iPod. Then remain holding for 8 seconds and release.



- b) BT-D5 has been reset, and in pairing mode.



FAQ (Frequently asked questions)

When I insert the BT-D5 into the iPhone or iPod, I do not see any LED indication.

You can try the following

- Unplug the BT-D5 and reinsert it into the iPhone or iPod
- Ensure that the iPhone or iPod is powered on
- Insert the BT-D5 into another iPhone or iPod to check if the BT-D5 flashes any LED indication
- Reset the BT-D5 by following steps in "To reset the BT-D5 and clear paired device memory"
- If the problem persists, please contact technical support

I have tried to put the BT-D5 into pairing mode but I am unable to connect to another Bluetooth device.

You can try the following

- Plug out the BT-D5 and re-insert it back into the iPhone or iPod. Wait for the Led to turn from steady blue to flashing then press the CONNECT button for 3 - 4 seconds and release. The LED indication should have changed to Fast Blink. Now put your receiving device into pairing mode and wait for pairing to be completed
- Reset the BT-D5 by following steps in "To reset the BT-D5 and clear paired device memory"
- If the problem persists, please contact technical support

No music is streaming from my computer to my speaker / other Bluetooth compliant device. What should I do?

You can try the following

- Close the offending program and re-open it again. Now start playing music
- Plug out the BT-D5 and re-insert it into the iPhone or iPod. Wait for the BT-D5 to connect successfully and try to stream music from your iPhone or iPod again

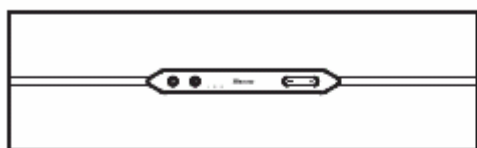

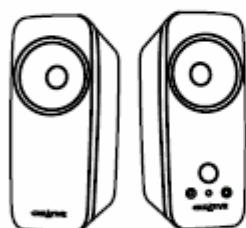

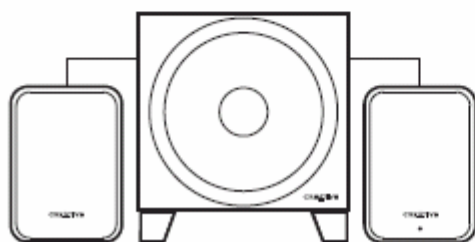
