

FCC Statement

Cette Creative BT-L4 répond aux exigences du gouvernement en matière d'exposition aux ondes radio. Les lignes directrices sont basées sur des normes établies par des organisations scientifiques indépendantes à travers une évaluation périodique et approfondie des études scientifiques. Les normes comprennent une marge de sécurité importante conçue pour assurer la sécurité de toutes les personnes, quel que soit leur sexe ou leur état de santé. Information et déclaration d'ISDE sur l'exposition aux RF la limite DAS du Canada (ISDE) est de 1.6 W / kg en moyenne sur un gramme de tissu.
