# Installation and Set up guide


After installing the Bluetooth module and driver to a computer, the user is able to send content between computer and another Bluetooth device by using Bluetooth wireless technology.


To connect your computer and phone using Bluetooth wireless technology

- 1. Turn on the Bluetooth function on computer and phone.
- 2. Double-click the Bluetooth icon on you computer.
- 3. Click "Add"
- 4. Select the box of "My device is set up and ready to be found" then click "Next".
- 5. Select the device you want to add and click "Next".
- 6. Select "Choose a passkey for me" the click "Next".
- 7. The wizard will off a passkey and please enter the passkey on your phone.
- 8. The wizard will pop up a window and inform you the Bluetooth connection established. Click "Finish" to close the wizard.
















To send a file using Bluetooth wireless connection.

- 1. Select the file you want to transfer.
- 2. Select where you want to send the file then click "Next".
- 3. The wizard will inform you when file transfer completed. Click "Finish" to close the wizard.
