



Bind Watch

1. Download and install App

You can set up the watch through the VeryFitPro app for iOS or Android devices. The steps are shown as follows:
Notes: The hardware platform of the equipment system shall meet requirements.

iOS 8.0 version or above
 Android 4.4 system or above
 Support Bluetooth 5.0

Correct operation: Scan the QR code below or download VeryFitPro APP through the mobile APP store to pair with the watch.

Wrong operation: Pair the watch directly with the bluetooth in your mobile phone's settings.

2. Bind process

① Turn on the Bluetooth and GPS on your mobile phone
 ② Find the binding request on the pull-down list on the home page of the APP
 Select product model: ID205
 Click "OK" to complete binding.

Synchronous Data

In daily wear, the watch can detect all kinds of product data. The user needs to connect the watch with bluetooth on the APP before synchronous operation. The detailed operations are shown as follows:

Open the mobile APP > swipe down the page > sync prompt appears

Notes:
 * Please synchronize the data at least once within 7 days to avoid data loss at the watch end.
 * The Apple phone also needs to be connected to the paired watch in the bluetooth setting interface of the mobile phone, so that the watch can be alerted. The steps are shown as follows:

Open the iOS phone > set > bluetooth > search and click pair

Instruction for Use

1. Charging schematic

Buckle the watch into the charger seat as shown in the picture. It needs to be charged to activate the watch when it is started for the first time.

2. Wear/install

Wear: Wear the wristband one finger away from the wrist bone and adjust the tightness of the wristband to a comfortable position.

Replace the strap: Flip the switch and take out the wristband

Tip: Wearing too loosely may affect the accuracy of heart rate data.

Operating Instructions

1. Definition of key function

Long press the left key: Enter the sports quickly
 Short press the right key: Return to previous interface
 Long press the right key: start

Left key setting steps: Function list > set > long press

2. Watch dial switch

Replacing the dial interface will appear after long pressing the dial.

3. Main interface operation

Swipe the screen to enter different interfaces (interactive interface tile diagram)

4. Dial data view (default dial)

Click the screen to switch different data

Function Introduction

1. Icon function introduction

- Sport:** Enter the sports window, and choose different sports modes. Change the sports mode on the APP
- Heart rate:** Perform a heart rate test to check your heart rate data for the day.
- Relax:** Help you regulate your breathing and relax your mood.
- Alarm:** View, turn off or turn on the alarm clock. You need to add an alarm clock on the mobile APP.
- Music controller:** Control music play on your mobile phone (watch cannot store music)
- Timer:** Have the timing and countdown function.
- Sports record:** Record recent sports.

Notes: For more functions (sleeping) and operation, please check the VeryFitPro software of the mobile phone.

2. Start sports

① Enter sports
Click the sports icon > select the sports type > enter the sports countdown automatically

② During sports
Pause sports: short press the right key
Restore sports: short press the right key

③ End sports
End sports: long press the right key > select the end button on the screen

3. Women's health tracking

Display location: in the data bar

Women's health tracking function, which is used for recording menstrual changes, tracks individual menstrual cycle and predicts ovulation (it needs to be enabled on the APP).

Cleaning and Maintenance

It is recommended to wear and maintain according to the following three points:
 ① Keep the product clean;
 ② Keep the product dry;
 ③ Do not wear it too tight.

* Do not use household cleaners to clean the watch, but use the soap free detergent.
 * It is recommended to use alcohol to scrub stains that are not easy to remove.

Frequently Asked Questions

1. Mobile APP search for the watch failed
 ① It is recommended to update VeryFitPro to the latest version.
 ② It is recommended to close all programs, restart the Bluetooth, and then connect.
 ③ Confirm whether the mobile phone system meets Android 4.4 or iOS 8.0 or above.

2. The watch received no alerts, text messages or phone calls
 ① You need to turn on the smart reminder function and the call reminder switch in the APP, and synchronize to the watch.
 ② The iPhone needs to be paired with the watch via Bluetooth. (Please check the column of "Synchronous Data" for details)
 ③ You need to keep your watch connected to Bluetooth.

3. Bluetooth is often disconnected
 ① If the distance between the watch and the mobile phone is too far, the connection effect of more than 7m bluetooth is obviously weakened.

Cycling Warning

- Watch data needs to be kept once every 7 days to avoid data loss.
- The watch has no waterproof effect on seawater, acidic and alkaline solutions, chemical reagents and other corrosive liquid. The damage or defects caused by misuse or improper use are not covered by the warranty.
- Sports mode supports up to 6 hours of exercise at a time.
- The watch has a waterproof level of 5ATM and supports cold water shower, swimming, but not diving.
- Avoid wearing the watch too tight in daily use. Please keep the parts of the watch touching the skin dry.
- When your heart rate is measured, keep your arm still during the test.
