











MINIMUM NOISE FIGURE, ASSOCIATED GAIN vs. FREQUENCY

OUTPUT POWER, DRAIN CURRENT, GATE CURRENT vs. INPUT POWER



RF MEASURING LAYOUT PATTERN (REFERENCE ONLY) (UNIT: mm)


