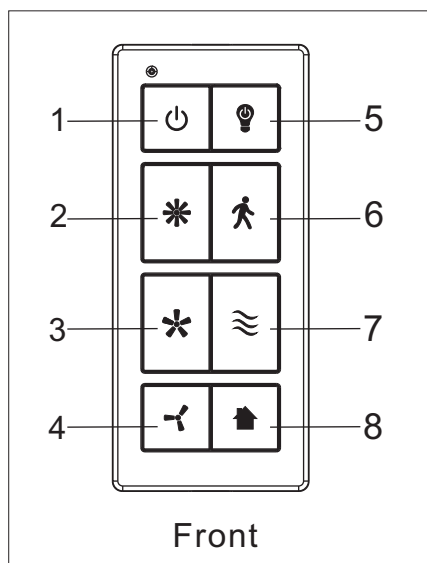

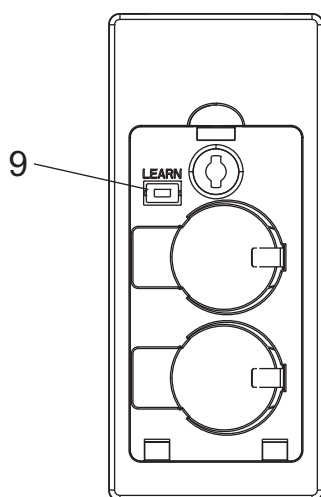

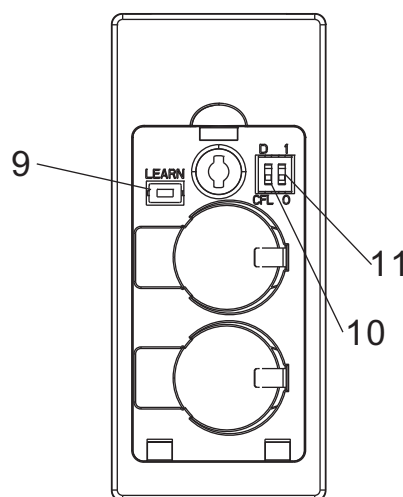

OPERATION INSTRUCTION

FCC STATEMENT
