Remote Control Functions:

1. FAN& LIGHT/OFF Button:
 - Press and release to turn the fan & light on or off.
 - Press and hold for 3 seconds to enter the "Walk away time delay".
2. FAN Speed Button:

Turns the the fan on High/Medium/Low speed and OFF.
3. LIGHT ON/OFF/DIMMING Button:

To control light on, off and dimming.
4. Comfort Breeze Button.
5. Sleep Timer Button.
6. Extended Function Switch R.
7. Extended Function Switch S.

Remote Control Functions:

1. FAN& LIGHT/OFF Button:
 - Press and release to turn the fan & light on or off.
 - Press and hold for 3 seconds to enter the "Walk away time delay" .
2. FAN Speed Button:

Turns the the fan on High/ Medium/ Low speed and OFF.
3. LIGHT ON/OFF/DIMMING Button:

To control light on, off and dimming.
4. Comfort Breeze Button.
5. Sleep Timer Button.
6. Extended Function Switch L.
7. Extended Function Switch R.
