Once you have finished your workout, return to the NuvitaCardio App on your phone. Tap "Pause". Now tap "Stop". You'll see a prompt that asks you to "Save Session". Tap save.

You will see a prompt that asks you to "Sync & Save"or "Discard Workout". Tap "Sync & Save".
