




 - 1.2. If the SMPS light is off, please check whether there is a disconnection. If all items are connected properly but the light is still off, please replace the SMPS and retry.
- 2. Press a switch key and check the LED light
 - 2.1. If the LED light is on, the system works.

- 2.2. If the light is on but the sofa still doesn't work, please replace the switch or the actuator, for the circuit may be the major cause of the fault. And please check whether there is a disconnection or any cuts or crimps in cables.
- 2.3. If the LED light is off, please check the SMPS. If the SMPS works, please replace the switch.

VII. Maintenance Instructions

- 1. Please do not use the non-water proof products in damp environment. No products are allowed to be washed with water. Cleaning with alcohol is allowed.
