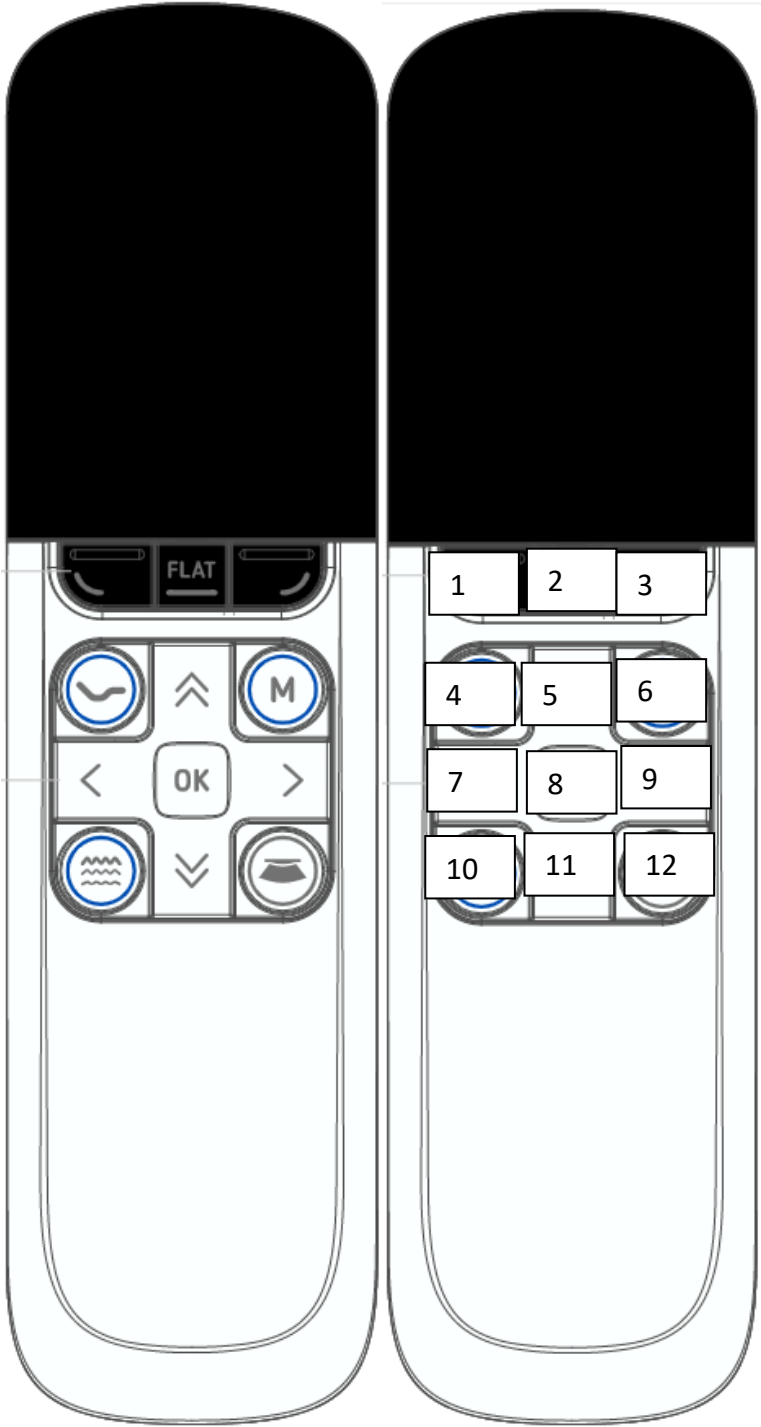

3.2 POSITION key test (Figure 2 Key 4)

Click this button, the display screen directly enters the motor control function interface

3.3 MEMORY Key Test (Figure 2 Key 6)

Press this button, and the screen displays the memory bit function

3.4 MESSAGE Button Test (Figure 2 Button 10)

Press this button to enter the message function screen

3.5 UBB Key test (Figure 2 Key 12)

Click this button to turn on/off the underbed light

3.6 Flat Key Test (Figure 2 Key 2)

Click the button to enter the Flat interface, and the control box can be placed flat.

3.7 Back Key Test (Figure 2 Key 1)

Click the key to perform the functions displayed in the lower left corner of the display

3.8 Enter key test (Figure 2 Key 3 and Key 8)

Click this button to perform the functions displayed at the lower right corner of the display.

3.9 UP key test (Figure 2 Key 5)

Click this button to select up on the screen

3.10 Down button test (Figure 2 Button 11)

Click the button, the interface downward selection function;

3.11 LEFT Button Test (Figure 2 Button 7)

Click the button to select the left side of the interface.

3.12 RIGHT Button test (Figure 2 Button 9)

Click this button to select the right side of the boundary.
