# 三. 操作说明:

连接上充电器插头供电后, 红蓝灯双闪三次完成产品自检后, 蓝灯常亮进入待机状态。

- 1. 待机状态: 红灯常亮
- 2. 充电状态: 蓝灯呼吸灯
- 3. 异物检测功能: 检测到异物阻挡时, 红、蓝灯闪亮, 移除异物,则红灯常亮
- 4. 标配:无线充主机,充电线(充电器插头需单独购买),使用说明书。

# 四. 安全须知:

- 11. 在不使用的情况下,请把产品充电器从插座上拔除, 避免消耗无线充使用寿命或造成损坏。


## 五. FCC警告:

### Operation Instruction

1.Use the included USB cable to connect this wireless charger with adapter,red and blue indicator light will flash 3 times to achieve Product Self-inspection.

The blue indicator light is always-on while in standby state.

Tips: The wireless charger panel with indicator light is charging area, please put the Qi-enabled Phones on the the pad with indicator light for well charging, otherwise, it won't work.

- 2.Standy State: red light is on;
- 3. Charging State: blue light is on;
- 4.Foreign Object Detection Fuctionswhen the device detect the wireless charging pad surface with metal objects, the indicator light will flash between red and blue, while remove the metal objects, the red light will be on.
  5. Full Charging State: Backlight will slowly flashes 3 times/sec.
- 6. Standard Kit: Wireless charger, Charging cable. (AC adapter is not included, please buy it separately), User manual.

## Safety Information

### Caution:

Please read following cautions to avoid the unexpected emergency during using the wireless charger.

- Do not directly touch the device when it is overheated, which may bring scald hurt.
