

PROPOSED DISPOSITION PURSUANT TO PRACTICE BOOK § 2-82(b)

Pursuant to Practice Book § 2-82(b), and Practice Book § 2-82(a)(2), the undersigned Respondent and Disciplinary Counsel stipulate and agree as follows:

1. Dmitry Paniotto (hereinafter Respondent), juris number 421477, was admitted to the bar of the State of Connecticut on June 10, 2003 and has no disciplinary history.

2. The Respondent has registered with the Statewide Grievance Committee for 2010 and is currently in good standing.

3. This matter was instituted by grievance complaint dated September 16, 2009.

4. On January 13, 2010 the Windham Judicial District Grievance Panel found probable cause that the Respondent violated Rules 1.2 (Scope of Representation and Allocation of Authority between Client and Lawyer), 1.5 (Fees) and 1.16(d) (Declining or Terminating Representation) of the Rules of Professional Conduct.

5. The Respondent has tendered an affidavit pursuant to Practice Book § 2-82(d) attached hereto, and admits that he failed to have a written fee agreement with the Complainant and that this conduct violated Rule 1.5(b) of the Rules of Professional Conduct.

6. The Respondent will ensure that written fee agreements are provided to clients at the time of engagement or within a reasonable time thereafter.

7. The Respondent and Disciplinary Counsel agree that the Respondent will be reprimanded pursuant to Practice Book §2-37(a).

8. The Respondent and Disciplinary Counsel agree that Disciplinary Counsel will recommend that the Statewide Grievance Committee impose the sanction set forth in this agreement.

WHEREFORE, this matter is submitted to the Statewide Grievance Committee for its approval in accordance with Practice Book § 2-82(b).


