

10. SOURCES OF INCOME & UTILISATION OF FUNDS :

(b) VICE-PRESIDENT :

In the absence of the President, they will work as a President and performed all the rights and duties of the President.

(c) GENERAL SECRETARY :

Powers of the General Secretary are as follows :

To sign on behalf of the society and to conduct its correspondence and to record the proceedings of such meeting.

To call ordinary General meeting if desired on the written request of at least 2/3rd members of the society.

(d) SECRETARY :

In the absence of the General Secretary, he/she will work as General Secretary and performed all the rights and duties of the General Secretary.

(e) TREASURER :

To keep accounts of all receipts and expenditure to the society and to furnish necessary information to the Managing committee. He will keep Rs.1000/- and the balance amount will have to be deposited in the Bank.

(v) QUORUM AND NOTICE OF THE MEETING :

The quorum for the meeting shall be 2/3rd numbers of total members existing at the time of such notice and the quorum of the General Body and Governing Body shall be 2/3rd.

(vii) FILLING UP CASUAL VACANCIES :

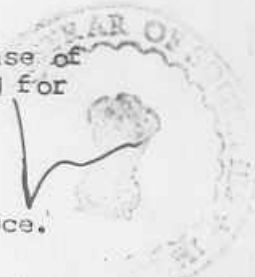
