

 Select proper wire size and type for load and application.
Use only applicable round cord and cables per electrical codes.
Device to be used with 16-3 cord and the following cord types:

SJT group, ST group, S group, SE group, SJ group, SJE group USE COPPER WIRE ONLY

- 2. Wiring preparation:
  - Select correct end of cord to ensure easy insertion of conductors. (Conductor sequence is important.)
  - Strip cord jacket and conductors as shown in Figure A. Twist strands. (Do not tin conductors.)
- Open the connector by separating its body and shell. (Note the plug/connector is keyed to the shell.)

- 4. Wiring method:
  - Slip outer shell onto the cord. Adjustment of cord clamps may be necessary depending on cord size.
  - Insert all conductors into identified terminal pockets.
    - Green wire to green terminal pocket.
    - White wire to silver terminal pocket.
  - Black wire to black terminal pocket.

     Tighten terminal screws
  - to 20 inch lb.
- 5. Assembly:
  - Slip shell into front section by aligning key on body with key in shell.
  - Evenly tighten assembly screws to 14 inch lb.
  - Evenly tighten cord grip screws to 14 inch lb.
