Steps to Becoming a Mississippi State Fire Academy

Adjunct Instructor

- 1 Request Application
- 2 Review Your Qualifications based on Minimum Requirements
- 3 If you qualify, complete and Submit Application forms
- 4 Application will be reviewed by the Fire Academy Executive Director, and Instructor Chief.
- 5 Application will be approved, denied, or held for further review.

If application is approved:

The Adjunct will receive a Contract for Professional Services in the mail. You will then receive the MSFA Adjunct Handbook outlining your duties.

Reasons for Denial:

- 1 Applicant can be denied if no openings are available.
- Applicant can be denied if the minimum requirements are not met or the application review team feels the applicant does not meet the minimum requirements. Application will be held for further review.

Fire Academy Adjunct Instructor Minimum Qualifications:

- 1. Applicant must have completed NFPA 1041-1, Fire Instructor.
- Applicant must have been in the fire service for a minimum of 3 years, volunteer or career service. (This may be a combination of the two.)
- Applicant must have a minimum of 1 year instructional experience outside or within the applicant's own department.
- 4. Applicant must submit a fifteen (15) minute video utilizing a short Fire Academy lesson plan and Power Point presentation.
- Applicant must sign the attached Authorization for Background Check.
