Amendment No. 6 To State Term Contract 518-020-10-1 Vehicle Rentals: Autos and Trucks

THIS AMENDMENT No. 6, effective as of March 1, 2013, by and between the Florida Department of Management Services (the "Department") and Avis Rent A Car Systems, Inc. (the "Contractor"), collectively "the Parties", amends State Term Contract No. 518-020-10-1.

WHEREAS, the Department awarded the above-referenced Contract to Avis Rent A Car Systems, Inc. for the provision of Rental Vehicle Services, Class: Autos; and

WHEREAS, in accordance with Section 5.18 of the subject contract, a price escalation or deescalation may be requested, by the Contractor or the Department at the time of the contract anniversary by using the Producer Price Index (PPI) for Passenger Car Rentals, Business Travel, as published by the U.S. Bureau of Labor Statistics. The rate adjustments will be based on the PPI (series id PCU53211153211211, Base Date 199812: July 2008: 117.4.); and

WHEREAS, based on the Producer Price Index (PPI) Table Containing PPI-U All Items Indexes and Annual Percent Changes (PPI Series ID: PCU53211153211211) demonstrates a decrease of 10.14% from the September 2011 anniversary date; and

WHEREAS, the Department recognizes that a 10.14% decrease would be financially detrimental to the Contractor, and the Parties have agreed to withdraw the last approved price increase of 4.9%;

NOW THEREFORE, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

- **1. Pricing Adjustment.** The Contract pricing is hereby reduced by 4.9%. The currently posted pricing table is replaced with Exhibit A, attached to this amendment.
- **2.** <u>Future Pricing Adjustments</u>. The Parties agree to amend Section 5.18 of the contract for Class: Autos to include a 5% rate adjustment cap. Section 5.18 for Class: Autos is amended to read:

5.18 Price Escalation/De-Escalation

(Class: Autos) Price Escalation/De-Escalation

A price escalation or de-escalation may be requested, by the Contractor or the Department at the time of the contract anniversary by using the Producer Price Index (PPI) for Passenger Car Rentals, Business Travel, as published by the U.S. Bureau of Labor Statistics. The rate adjustments will be based on the PPI (series id PCU53211153211211, Base Date 199812: July 2008: 117.4) and may not exceed 5 percent.

- **Mileage Cap Requests.** The Contractor agrees to refrain from requesting to establish or impose a mileage cap for the remainder of the original contract term, which expires September 29, 2014.
- **4.** Other Contract Terms. Unless specifically modified or made inapplicable by this Amendment No. 6, all terms and conditions of the Contract remain in full force and effect.
- **5.** <u>Effective Date.</u> Unless specifically provided otherwise, the terms and conditions of this Amendment No. 6 shall take effect March 15, 2013.
- **6.** <u>Warranty Of Authority</u>. Each person signing this Agreement warrants that he or she is duly authorized to do so and to bind the respective party.
