

## **BASIC FACTS & FIGURES:**

## **NONPROFIT HEALTH PLANS<sup>1</sup>**

- Of the 154 health plans in the United States with at least 100,000 enrollees, 97 (or 63%) are nonprofit, 41 are for-profit (27%), and 16 (10%) are government.
- Of the 230,773,945 total enrollees in these 154 health plans, 104,273,365 (or 45%) are in nonprofit health plans. Fifty-seven percent (57%) of total enrollees (or 132,427,681) are fully insured lives and, of these, 50% come from nonprofit health plans.
