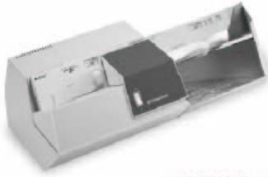

Terms and Conditions Applicable to Rental of Equipment other than Postage Meters.

Purpose. The Rental Program is available for the rental of all equipment covered by the Pitney Bowes GSA contract GS-25F-0010M (the "GSA Contract"), other than the IntelliLink™ Control Centers and Postage Meters and unless otherwise noted in the published GSA price list. **Rental equipment may be new or reconditioned at Pitney Bowes option.**

Invoicing. Invoices are issued quarterly in arrears and the net amount is payable upon receipt.

Rental Rate. The monthly rental rate shall be **4 1/2%** of the net Government price shown in the Federal Supply Schedule Price List covering the GSA Contract. Net Government price includes any applicable program allowances. Prices for new or reconditioned equipment are the same.

Maintenance. All rentals include maintenance at no additional cost. Consumable parts and supplies such as but not limited to rubber belts, rollers, felt ink rollers, sealer and moistener brushes are not guaranteed against fair wear and tear and shall be replaced at the cost of the Customer. In addition, **scale PROM'S are not guaranteed against obsolescence** caused by changes or errors in USPS or private delivery carriers special rate structures **and shall be replaced at the cost of the Customer.**

Duration of Rental. The rental period shall be a minimum of twelve (12) months from date of installation of the equipment. However, if the Fiscal Year expires during the initial twelve (12) month term and funding for the rental under the GSA Contract is eliminated from the following Fiscal Year's budget, the rental may be terminated on thirty days written notice without cost to the Customer. The GSA Contract shall be terminated at the end of the first twelve (12) months by written notice thirty days prior to the end of the period. Thereafter, rental may be continued on a month-to-month basis and may be terminated at any time on thirty (30) days written notice.

Pricing. The rental charge shall remain in effect during the initial twelve (12) month term. All Charges are subject to change after the initial term.

Any individually identifiable information that we obtain about you in this manner will not be shared by us with any third parties. From time to time, we may elect in our sole discretion to share aggregate data about our customers' postage uses with third parties. Please contact us if you have any questions about these data collection and/or sharing practices. You will notify Pitney Bowes prior to moving the IntelliLink™ Control Center or Meter to a different location. In order to obtain postage, IntelliLink™ Control Center or Meter, you must contact Pitney Bowes' POSTAGE BY PHONE® data center. Postage refill fees if any will not increase during the Initial Term but thereafter refill fees may be increased upon 30 days prior written notice.
