## **BOY SCOUT CODE BLUE CAMPOREE OCTOBER 4-6, 2013 RIVERFRONT PARK, MARIETTA, PA**



### Registration and Information News:

**Event News and Details** - The event is based on first aid skills, but more exactly will be an overview of the new "Search and Rescue" merit badge. Many, but not all of the requirements for the badge will be reviewed, discussed, and done over the course of the weekend. One requirement that will not be done at the camporee is #5, which is complete an online training course.

Activities in the morning (9am to noon) will be set up round robin style, covering some of the search and rescue skills, as well as general first aid skills that you need after "finding" the victim. The afternoon (1pm to 5pm) will be implementing those skills in search and rescue scenarios.

Later in the afternoon, there will be special presentations for the whole camp to be involved in.

Saturday night there will be a search exercise after dark, trying to find the hidden glow sticks. Friday night if time allows we may do requirement #1 as a group.

For those scouts or units wishing to complete this badge Req. #5 needs to be done. It is an online training course called ICS-100, Introduction to Incident Command System. It can be found at <http://emilms.fema.gov/IS100b/index.htm>

**Camping** – Camping is at Riverfront Park, just north of Marietta. (*take 441 north out of Marietta about 1 mile. Take a left onto Vinegar Ferry Road. It lead right into the park*) The park has water, a pavilion with electric, but no bathrooms. Porta potties will be brought in for the weekend. The area is right along the Susquehanna, so depending on the weather, it may be wet or buggy. There is wide open space for programs and camping though. The park will remain open to the public for the weekend so remember your Scout manners.

**NO GROUND FIRES!** No ground fires are allowed. No dumping of coals or ash on the ground. Plan your menu accordingly.
