<u>Please log in with CorpPass</u> to ensure that the Certificate of Registration will be correctly granted to your <u>business entity</u> that is registered with ACRA or a relevant UEN Issuance Agency, whether you are a sole proprietorship, partnership, company, corporation, limited liability partnership and limited partnership. CorpPass is now the only login method for online corporate transactions with government digital services. To apply for your CorpPass account, please visit <u>https://www.corppass.gov.sg</u>.

There should be only one application per business entity (i.e. one application per UEN.)

Do NOT log in with SingPass/LicenceOne ID unless you are exempted from registration with ACRA, and are registering in your personal capacity as an <u>individual</u> dealer. You may refer to the table below for the log in methods.
