**Step Two - Visit a Participating Store:** You may use your card at participating stores. You do not need a prescription and do not need to go to the pharmacy window. Remember to take your card with you when you go to any of the listed stores, as you will need the card to pay for your eligible items.

**Step Three – Pay at the Front of the Store:** Take your eligible items and go to the main store check out lanes. When you check out, swipe the card for payment. Eligible items (up to the balance amount on the card) are covered. You can use any remaining balance for another purchase before the end of the month).
