HEALTH EFFECTS

SWALLOWED:	Can cause irritation. If a large quantity is ingested seek immediate medical attention. Give copious amounts of water or milk to drink. DO NOT induce vomiting. If vomiting occurs get immediate medical attention due to aspiration into lungs risk.
EYE:	Can cause irritation. Immediately irrigate with copious amounts of water for at least 15 minutes. Eyelids to be held open. In all cases of eye contamination it is a sensible precaution to seek medical advice.

5. FIRE FIGHTING MEASURES

FIRE/EXPLOSION HAZARD

HAZARDS OF USE/STORAGE:	Product is not combustible under normal conditions. Under fire conditions the water component may evaporate and the residue may break down and may burn. It is not considered to be a fire risk.
HAZARDS FROM COMBUSTION PRODUCTS:	Heating may cause expansion leading to a violent rupture of the containers. Product may decompose on heating as above and may produce toxic fumes such as oxides of carbon.
FIRE-FIGHTING RECOMMENDATIONS:	If safe to do so, remove containers from path of fire. Keep storage tanks, pipelines, containers, fire exposed surfaces, etc. cool with water spray. Avoid spreading liquid and fire by water flooding.
SUITABLE EXTINGUISHING MEDIA:	Use water, foam, carbon dioxide or dry chemical.
PROTECTIVE MEASURES:	Fire fighters should wear self-contained breathing apparatus if risk of exposure to products of combustion.
REACTIVITY:	May react with strong oxidising agents.

6. ACCIDENTAL RELEASE MEASURES

SPILLS & DISPOSAL:	Slippery when spilt. Avoid accidents, clean up immediately.
	CLEAN-UP PROCEDURE - SMALL SPILLS (20L or less): Absorb or contain liquid with sand, earth or spill control material. Shovel up using non- sparking tools and place in a sound labelled sealable container for subsequent safe disposal. Place leaking containers in a sound labelled drum. Rinse then scrub contaminated surfaces with water. Retain washings as contaminated waste.
	CLEAN-UP PROCEDURES - LARGE SPILLS (Greater than 20L): Transfer to a sound labelled, sealable container for product recovery or safe disposal. Treat residues as for small spills.
	PERSONAL PRECAUTIONS: Extinguish naked flames. Remove ignition sources. No smoking. Avoid sparks. Avoid contact with skin, eyes and clothing. Evacuate the area of non-essential personnel. Shut off leaks, if possible without personal risk. Do not breathe vapours. Ventilate contaminated area thoroughly. Dispose of according to local regulations.
OTHER INFORMATION:	PROCEDURES IN CASES OF LEAKAGE OR BREAKAGE: Stop the source of the leak or release and contain spill if possible. Ventilate area. Use respirator and protective clothing outlined in this MSDS. Cover spill with inert absorbent earth or wipe up. Clean up and place in a sound labelled disposable container. Scrub contaminated area with water using a stiff brush. Pick up liquid with additional absorbent material and place in a sound labelled disposable container. Prevent contamination of groundwater or surface water.

7. HANDLING AND STORAGE

PRECAUTIONS FOR SAFE HANDLING:	When handling product in drums, safety footwear should be worn and proper handling equipment should be used. Prevent spillages. Ensure the appropriate personal protective equipment is used when handling this product. Ensure high level of personal hygiene is maintained when using this product. That is; always wash hands before eating, drinking, smoking or using the toilet.
SAFE STORAGE CONDITIONS:	Keep containers closed at all times. Store in a cool place out of direct sunlight. Store away from oxidising agents and acids. Check containers regularly for leaks.
CORROSIVENESS:	Concentrated product has longer term corrosive tendencies.
STORAGE REGULATIONS:	Store in a well ventilated place away from ignition sources, oxidising agents, acids, foodstuffs and clothing. Keep containers closed when not in use. Refer to AS 1940 – The Storage and Handling of Flammable Liquids, and NOHSC: 1015 – National Standard for Storage and Handling of Workplace Dangerous Goods for further information.

NATIONAL EXPOSURE STANDARDS:	No exposure standard has been established for this product. NOHSC Exposure Standard: Sodium Hydroxide – time weighted average (TWA) 2 mg/m ³ is recommended.
OTHER EXPOSURE INFORMATION:	Exposure Standard means the average concentration of a particular substance in the worker's breathing zone, exposure to which, according to current knowledge, should not cause adverse health effects nor cause undue discomfort to nearly all workers.
