The Techno-commercial bids having requested EMD will be opened on the same day at 3:30 PM in presence of the bidders present. Financial bids will be opened only after the technical evaluation.

Eligibility criteria for financial bid opening:

- a. Bidder should have minimum 2 year experience in providing AMC support to corporate offices (clientele list and customer satisfaction reports from 3 corporate customers to be attached).
- b. An amount of Rs. 10,000/- should be remitted as EMD in the form of demand draft from any of the nationalized banks drawn in favour of 'The Director, RRII, Rubber Board' payable at Kottayam to be accompanied with the techno-commercial bid.
- c. Bidder should have a local office at Kochi/Kottayam area and must be able to support our outstation offices at Thiruvananthapuram, Kozhikode, Adoor, Moovattupuzha, Trissur, Kannur, Ranni(Pathanamthitta) and Mangalore.
- d. The bidder should maintain an onsite resident engineer with adequate qualification and skills at RRII, Kottayam to look after daily complaints. Qualification of the resident engineer is 3 year diploma in computer hardware with minimum 2 years' experience in PC, Laptop trouble shooting (attach bio-data and experience of resident engineer) and Layer 3/ Layer 2 network switch configuration.
- e. The provider should have minimum 3 service engineers in their local offices to provide a substitute resident engineer.

Terms and conditions:

- 1. The bidder should be capable of providing 24 x 7 same business day service. Hardware and software support shall be provided with troubleshooting, installation, repairing, reinstallation, configuration, data migration, AV security policy setup, backup, restore etc.
- 2. The bidder should attend all service calls within 2 hours and rectify all reported complaints within 24 hours using genuine spares. The bidder should provide spare units of equivalent configuration of the same OEM/ MNC make in the event of a unit cannot be rectified within 24 hours. Non attending calls/ service defaults beyond 24 hours will attract a fine of Rs. 100/- per day per complaint.
- The bidder should maintain minimum 5 spares of all components at RRII to avoid delay in getting service. Excuses for spares beyond 24 hours not allowed.

- 4. The bidder should maintain back to back support with OEM like HP,CISCO,DELLetc for proprietary spare components(proof to be supported).
- 5. Bidders not having back to back support with OEMs will be a disqualification.
- 6. The bidder should attach profile, contact details and clear cut service escalation matrix with the quotation.
- 7. Toll free/ email based call login facility, landline contacts, complaint token issue, feed back processing and weekly consolidation of service from the monitoring cell.
- 8. Payment agreed is quarterly payment against satisfactory service.
- 9. Quotation should be valid for a period of 90 days from the last date of submission.
- 10. The AMC is called for a period of one year but likely to extend further without changing terms and rates.
- 11. All inclusive unit rate per items may be offered with tax components noted separately.
