为了连续性，我这里不会按照学期的顺序，而是按照课程的连贯性，比如我会将微积分单独作为一个部分来详尽阐述。

1.1. Calculus

跟上面一样, 很 137 failed 的人或者说达不到138的要求就会来上这个课, 其实难度上并无太大差别。

虽然其他有些低级别的课也可以是 math major 的课, 不过正常来说接下来才是真正的数学系的课。

这门课对于作为大学第一门入门微积分课一定要好好学, 为以后的知识打好基础。其实我觉得这门课太简单了, 没什么好多说的, 不过还是多说一下吧, 因为很多新生刚来难以适应大学的课程模式和结构, 当然大佬除外。

这门课之前是由作业构成的, 然后也一直在2017 fall 改版了, 增加了proof的部分, 当然难度跟math147当然不能比。2018 fall 把原有的作业全部改成weekly quiz。虽然难度不大, 但是quiz的目的就是督促人及时复习, 而不是拖到考试再复习。

还有一点就是证明要写清楚, 不要伪证或者跳步骤。本来就不是很难的证明, 一定要尽量拿满分。

1.1.2.2. Final Note

这门课的好prof应该挺多的，不过clas分配的prof据说是真的差，上课都不能自圆其说，然后Jordan讲得又太好了，导致很多人都去蹭Jordan的课。如果教室大还好，教室小了很多enroll的人就只能站着，所以很多人在第一学期蹭课就遭遇查ID的情况。我建议最好能抢到他课，抢不到的话就蹭吧，查ID的话就蹭别的好prof吧，像Eddie等等。当然Jordan的review session还是非常值得去的，很多情况下都是类似的题目，如果有机会蹭的话可以去蹭一下。

这门课还有一个physics-based section，很多地方都应用到物理上了。如果不感兴趣物理不建议上这个。当然有些人可能专业需要，那还是上吧，难度也不会大的离谱。

传说中难度陡然增大的课。相比137确实难了不少。¹137很多同学都在吃老本，138讲积分很多同学也吃一点老本，后面讲级数series就没得吃了。下个学期怎么改我不太清楚，我就先说说我这个学期吧。

1.1.3.2. Final Note

很多人上完这门课，微积分就结束了，因为general cs不需要后面的微积分了。微积分相比线代对cs的作用不是那么大，但是还是看选择的cs方向。如果选择computer graphics的话，建议接着往下学微积分 (math237)。cs370 (Numerical Computation) 是cs488(computer graphics)的preq。如果要上cs370，微积分的底子就显得尤为重要了。

很久以前cs是必修4门微积分的 (amath231)²。后来cs考虑到要上更多的cs课，就把微积分必修的要求减轻了，只用两门了。当然从现在的水平来看，微积分确实没有很大的用处，所以先学着备着吧，假如将来真的做computer graphics，微积分的用处就显现出来了。

再说一个用处，当然这是建立在对数学很感兴趣的前提下，如今很多人对数学也就是专业需要就学一下，并没有很大兴趣。好了，进入正题。pmath365 (differential geometry, 微分几何) 也是很有趣的一个数学subject, preq: amath231/math247, 这是很需要微积分做底子的，不过更多的是从分析、理论的层面上，不是像math137/138 或者amath等等从应用的层面上。学完这个，就能感受到数学之美了³。还有pmath467 (Algebraic Topology), preq: pmath347/351。这个偏代数，但是学起来一定是很有趣的。

还有以后如果想学习real/complex analysis, 微积分也是尤为重要的。当然如果137/138上过来，要pmath333过渡一下到pmath351/352，或者图简单，上pmath331/332也行，但是这个简单的版本偏应用，理论相对较少，所以难度也是降低了很多。

如果从amath专业来考虑的话，微积分要学好，然后real/complex analysis学baby version 就够了，多学点应用便好。相反的，pmath专业或者enthusiasts 学351/352 就比较好，见识和学习到更多数学好玩的地方。

Theorem 1.1.1

Suppose f is in C^1 at $\vec{a}$, then f is differentiable at $\vec{a}$.

Proof

► (for $n = 2$, but the proof is identical for any n .)

Denote the function by $f(x, y)$, and the point $\vec{a} = (a, b)$.

1. Basic Math

Our hypothesis: f_x, f_y both exist near (a, b) and are continuous at (a, b)

The linear approximation is

$$L(x, y) = f(\vec{a}) + (\nabla f)(\vec{a}) \cdot (\vec{x} - \vec{a}) = f(a, b) + f_x(a, b)(x - a) + f_y(a, b)(y - b)$$

We want to show

$$\lim_{(x,y) \rightarrow (a,b)} \frac{|f(x, y) - L(x, y)|}{\sqrt{(x-a)^2 + (y-b)^2}} = 0$$

$$\begin{aligned} f(x, y) - L(x, y) &= f(x, y) - f(a, b) - f_x(a, b)(x - a) - f_y(a, b)(y - b) \\ &= \underbrace{f(x, y) - f(a, y)}_{f_x(x_0, y)(x-a) \text{ by (2)}} + \underbrace{f(a, y) - f(a, b) - f_x(a, b)(x - a) - f_y(a, b)(y - b)}_{f_y(a, y_0)(y-b) \text{ by (3)}} \end{aligned} \quad (1)$$

Consider the function

$$h(t) = f(t, y) \quad \text{on } [a, x] \quad (y \text{ is fixed})$$

$h'(t) = f_x(t, y)$. By hypothesis, f_x exists near (a, b) , so h is differentiable on $[a, x]$ for x close to a .

Apply MVT to this situation: there exists x_0 between a and x such that

$$\begin{aligned} h(\underbrace{x}_{t_2}) - h(\underbrace{a}_{t_1}) &= h'(\underbrace{x_0}_{t_0})(\underbrace{x-a}_{t_2-t_1}) \\ f(x, y) - f(a, y) &= f_x(x_0, y)(x - a) \end{aligned} \quad (2)$$

Consider the function

$$k(s) = f(a, s) \quad \text{on } [y, b] \quad (a \text{ is fixed})$$

$k'(s) = f_y(a, s)$ exists near (a, b) , so k is differentiable on $[y, b]$ for y close to b .

Let $s_1 = y, s_2 = b$. Apply MVT, there exist y_0 between b and y such that

$$\begin{aligned} k(s_0) - k(s_1) &= k'(y_0)(s_2 - s_1) \\ f(a, y) - f(a, b) &= f_y(a, y_0)(y - b) \end{aligned} \quad (3)$$

We've shown that: there exists x_0 between a and x and there exists y_0 between b and y such that

$$\frac{f(x, y) - L(x, y)}{\sqrt{(x-a)^2 + (y-b)^2}} = \frac{(x-a)[f_x(x_0, y) - f_x(a, b)]}{\sqrt{(x-a)^2 + (y-b)^2}} + \frac{(y-b)[f_y(a, y_0) - f_y(a, b)]}{\sqrt{(x-a)^2 + (y-b)^2}}$$

We want to show this $\rightarrow 0$ as $(x, y) \rightarrow (a, b)$.

$|A + B| \leq |A| + |B|$ also

$$\frac{|x-a|}{\sqrt{(x-a)^2 + (y-b)^2}} \leq 1 \quad \frac{|y-b|}{\sqrt{(x-a)^2 + (y-b)^2}} \leq 1$$

1. Basic Math

Then

$$\frac{f(x, y) - L(x, y)}{\sqrt{(x-a)^2 + (y-b)^2}} \leq \underbrace{|f_x(x_0, y) - f_x(a, b)|}_{\substack{\rightarrow 0 \text{ as } (x,y) \rightarrow (a,b) \\ \text{since } f_x \text{ is continuous} \\ \text{at } (a,b)}} + \underbrace{|f_y(a, y_0) - f_y(a, b)|}_{\substack{\rightarrow 0 \text{ as } (x,y) \rightarrow (a,b) \\ \text{since } f_y \text{ is continuous} \\ \text{at } (a,b)}}$$

So by Squeeze Theorem

$$\lim_{(x,y) \rightarrow (a,b)} \left| \frac{f(x, y) - L(x, y)}{\sqrt{(x-a)^2 + (y-b)^2}} \right| = 0$$

So f is differentiable at (a, b) □

Example Prove that $\int_0^\infty e^{-x^2} dx$ converges, and find the value N .

Proof

►

$$\begin{aligned} 2N &= \int_{-\infty}^{\infty} e^{-x^2} dx = \int_{-\infty}^{\infty} e^{-y^2} dy \\ 4N^2 &= \int_{-\infty}^{\infty} e^{-x^2} dx \int_{-\infty}^{\infty} e^{-y^2} dy \\ &= \int_{-\infty}^{\infty} \left[\int_{-\infty}^{\infty} e^{-x^2} dx \right] e^{-y^2} dy \\ &= \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} e^{-(x^2+y^2)} dA \\ &= \iint_{\mathbb{R}^2} e^{-(x^2+y^2)} dA \end{aligned}$$

Change to polar coordinates $\begin{cases} 0 \leq r \leq \infty \\ 0 \leq \theta \leq 2\pi \end{cases}$

$$\begin{aligned} 4N^2 &= \int_0^{2\pi} \int_0^\infty e^{-r^2} \underbrace{r dr d\theta}_{dA} \\ &= 2\pi \int_0^\infty e^{-r^2} r dr = 2\pi \left(-\frac{1}{2} e^{-r^2} \right) \Big|_0^\infty = \pi \end{aligned}$$

Hence $N = \frac{\sqrt{\pi}}{2}$ □

$$\iint_S \mathbf{F} \cdot \widehat{\mathbf{N}} \, dS = \iint_{\mathcal{D}_{uv}} \mathbf{F}(\mathbf{g}(u,v)) \cdot \mathbf{N}(u,v) \, dA$$

- * Gauss Divergence Theorem in $\mathbb{R}^3$

$$\underbrace{\iint_S \mathbf{F} \cdot \widehat{\mathbf{N}} \, dS}_{\text{surface integral}} = \underbrace{\iiint_D \operatorname{div} \mathbf{F} \, dV}_{\text{volume integral}}$$

- Let $U(t)$ denote the total amount of substance X in region D at time t . $u(\mathbf{x}, t)$ denote the concentration of substance X at a point $\mathbf{x} \in R \subset \mathbb{R}^3$.

$$U(t) = \iiint_D u(\mathbf{x}, t) \, dV \implies U'(t) = \iiint_D \frac{\partial u}{\partial t}(\mathbf{x}, t) \, dV$$

- The flow of X is defined by the flux density vector $\mathbf{j}(\mathbf{x}, t)$. The net outward substance X through an infinitesimal element of surface area dS centered at point $x \in \partial D$ is given by $\mathbf{j}(\mathbf{x}, t) \cdot \widehat{\mathbf{N}}(\mathbf{x}) \, dS$. The total outward flux: $\iint_{\partial D} \mathbf{j}(\mathbf{x}, t) \cdot \widehat{\mathbf{N}}(\mathbf{x}) \, dS$. By Divergence Theorem, we have

$$\iint_{\partial D} \mathbf{j}(\mathbf{x}, t) \cdot \widehat{\mathbf{N}}(\mathbf{x}) \, dS = \iiint_D \vec{\nabla} \cdot \mathbf{j}(\mathbf{x}, t) \, dV$$

- and $U'(t) = - \iiint_D \vec{\nabla} \cdot \mathbf{j}(\mathbf{x}, t) \, dV$, then **integral form of the conservation law** for substance X:

$$\iiint_D \left(\frac{\partial u}{\partial t}(\mathbf{x}, t) + \vec{\nabla} \cdot \mathbf{j}(\mathbf{x}, t) \right) \, dV = 0$$

- ∇ operator

$$\nabla \times \mathbf{F} = \begin{vmatrix} \mathbf{i} & \mathbf{j} & \mathbf{k} \\ \frac{\partial}{\partial x} & \frac{\partial}{\partial y} & \frac{\partial}{\partial z} \\ F_1 & F_2 & F_3 \end{vmatrix}$$

$$\frac{\partial u}{\partial v_1} = \frac{\partial u}{\partial x} \frac{\partial x}{\partial v_1} + \frac{\partial u}{\partial y} \frac{\partial y}{\partial v_1} = \nabla u \cdot \frac{\partial \mathbf{x}}{\partial v_1}$$

∇ in polar/cylindrical/spherical coordinates in $\mathbb{R}^3$

- Stoke's Theorem

$$\int_C \mathbf{F} \cdot d\mathbf{x} = \iint_S (\nabla \times \mathbf{F}) \cdot \widehat{\mathbf{N}} \, dS$$

- final calculation (using spherical polar coordinate is easiest)

$$\mathbf{F} = \frac{1}{r^n} \mathbf{r} = \frac{1}{(x^2 + y^2 + z^2)^{n/2}} [x\mathbf{i} + y\mathbf{j} + z\mathbf{k}] \implies \vec{\nabla} \cdot \mathbf{F} = \frac{3-n}{r^n}$$

$$f(x) = \frac{a_0}{2} + \sum_{n=1}^{\infty} a_n \cos nx + \sum_{n=1}^{\infty} b_n \sin nx, \quad x \in [-\pi, \pi]$$

- pointwise convergence for a Fourier series (2π -period and piecewise C^1)

- even & odd extension of a function defined on $(0, \pi)$

$$\langle f_n, f_n \rangle = \frac{a_0^2}{2} \pi + \pi \sum_{k=1}^n [a_k^2 + b_k^2] \leq \|f\|_2^2$$

- $\{f_n\}$ converges pointwise to f : $\lim_{n \rightarrow \infty} |f_n(x) - f(x)| = 0$, for all $x \in [a, b]$.

- Series $\sum_{k=1}^{\infty} a_k$ in $C[a, b]$ converges uniformly to f means that the sequence $\{S_n\}$ of partial sums converges uniformly to f

$$\lim_{n \rightarrow \infty} \left\| f - \sum_{k=1}^{\infty} a_k \right\|_{\infty} = 0$$

- Series $\sum_{k=1}^{\infty} a_k$ in $C[a, b]$ converges in the mean to f means that the sequence $\{S_n\}$ of partial sums converges in the mean to f

$$\lim_{n \rightarrow \infty} \left\| f - \sum_{k=1}^{\infty} a_k \right\|_2 = 0$$

- Weierstrass M-test (also covered in MATH 148): If $|a_n(x)| < M_n, \quad \forall x \in [a, b]$, $\sum_{n=1}^{\infty} M_n$ converges, then $\sum_{n=1}^{\infty} a_n(x)$ converges absolutely for each $x \in [a, b]$, with sum $f(x)$, it converges uniformly to $f(x)$ on $[a, b]$.

- * f_p piecewise continuous $\implies$ converges in the mean to f_p on any finite interval

- * f_p piecewise $C^1 \implies$ converges pointwise to f_p for all $x \in \mathbb{R}$

- * f_p piecewise C^1 and continuous $\implies$ converges uniformly to f_p on any finite interval

- Complex Fourier series of a τ -periodic function

- Parseval's formula: $\langle f, f \rangle = \|f\|_2^2 = \int_{-\frac{\tau}{2}}^{\frac{\tau}{2}} f(t)^2 dt = \tau \sum_{n=-\infty}^{\infty} |c_n|^2$

- Fourier Transform:

$$\mathcal{F}\{f(t)\} = F(\omega) = \int_{-\infty}^{\infty} f(t) e^{-i\omega t} dt$$

3.1.2. Selected Proof

Conservation of Energy Assumptions: $\mathbf{F} : \mathbb{R}^n \rightarrow \mathbb{R}^n$ is conservative.

Proof

►

$$E(t) = \frac{1}{2} m \|\mathbf{v}(t)\|^2 + V(\mathbf{x}(t))$$

3. AMATH

$$E'(t) = \frac{m}{2} \frac{d}{dt} [\mathbf{v}(t) \cdot \mathbf{v}(t)] + \frac{d}{dt} V(x_1(t), \dots, x_n(t))$$

$$\frac{d}{dt} [\mathbf{v}(t) \cdot \mathbf{v}(t)] = \mathbf{v}'(t) \cdot \mathbf{v}(t) + \mathbf{v}(t) \cdot \mathbf{v}'(t) = 2\mathbf{a}(t) \cdot \mathbf{v}(t)$$

By chain rule:

$$\frac{d}{dt} V(x_1(t), \dots, x_n(t)) = \frac{\partial V}{\partial x_1} \frac{dx_1}{dt} + \dots + \frac{\partial V}{\partial x_n} \frac{dx_n}{dt} = \vec{\nabla} V \cdot \mathbf{v}$$

Put together,

$$E'(t) = \mathbf{v}(t) \cdot [m\mathbf{a}(t)] + \mathbf{v}(t) \cdot \vec{\nabla} V = \mathbf{v}(t) \cdot [m\mathbf{a}(t) + \vec{\nabla} V] = \mathbf{v}(t) \cdot [m\mathbf{a}(t) - \mathbf{F}(\mathbf{x}(t))] = \mathbf{v}(t) \cdot \mathbf{0} = 0$$

□

Work Integrals

$$\mathbf{F} = -\vec{\nabla} V$$

Proof

►

$$W = \int_{C_{AB}} \mathbf{F} \cdot d\mathbf{x} = \int_{C_{AB}} \vec{\nabla} V \cdot d\mathbf{x} = -[V(B) - V(A)] = V(A) - V(B) = -\Delta V$$

□

Second Fundamental Theorem of Line Integrals Let $\mathbf{F} : \mathcal{U} \rightarrow \mathbb{R}^n$ be a continuous vector field on a connected open set $\mathcal{U} \subset \mathbb{R}^n$, and let $\mathbf{x}_1, \mathbf{x}_2$ be two points in $\mathcal{U}$. If $\mathbf{F} = \nabla f$, where $f : \mathcal{U} \rightarrow \mathbb{R}$ is a C^1 scalar field, and $\mathcal{C}$ is any curve in $\mathcal{U}$ joining $\mathbf{x}_1$ to $\mathbf{x}_2$, then

$$\int_{\mathcal{C}} \mathbf{F} \cdot d\mathbf{x} = f(\mathbf{x}_2) - f(\mathbf{x}_1)$$

Proof

► Let $\mathcal{C}$ be given by $\mathbf{x} = \mathbf{g}(t)$, $t_1 \leq t \leq t_2$, so that $\mathbf{x}_1 = \mathbf{g}(t_1)$, $\mathbf{x}_2 = \mathbf{g}(t_2)$. By the hypothesis,

$$\begin{aligned} \int_{\mathcal{C}} \mathbf{F} \cdot d\mathbf{x} &= \int_{\mathcal{C}} (\nabla f) \cdot d\mathbf{x} \\ &= \int_{t_1}^{t_2} \nabla f(\mathbf{g}(t)) \cdot \mathbf{g}'(t) dt && \text{by definition of line integral} \\ &= \int_{t_1}^{t_2} \frac{d}{dt} [f(\mathbf{g}(t))] dt && \text{Chain rule} \\ &= f(\mathbf{g}(t_2)) - f(\mathbf{g}(t_1)) && \text{second FTC} \\ &= f(\mathbf{x}_2) - f(\mathbf{x}_1) \end{aligned}$$

□

Proposition 5.1

$$\begin{aligned} \|f\|_2^2 &= \int_a^b f(x)^2 dx \\ &\leq \max_{a \leq x \leq b} [f(x)]^2 (b-a) \\ &= \left[\max_{a \leq x \leq b} |f(x)| \right]^2 (b-a) \\ &= (b-a) \|f\|_\infty^2 \end{aligned}$$

Proposition 5.2 If f_n converges uniformly in piecewise continuous $[a, b]$, then converges in (i) mean and (ii) pointwise. **Proof**

► For (i), use prop 5.1 and squeeze theorem. For (ii) by definition, $|f_n(x) - f(x)| \leq \|f_n - f\|_\infty$, then... $\square$

- An equation relating an unknown function and one or more of its derivatives is called a differential equation.
- The order of a differential equation is the order of the highest derivative that appears in it.

- Ordinary differential equations: the unknown function (dependent variable) depends on only a single independent variable.
- If the dependent variable is a function of two or more independent variables, then partial derivatives are likely to be involved; if they are, the equation is called a partial differential equation.

- **Theorem** Existence and Uniqueness of Solutions

$\frac{dy}{dx} = f(x, y)$, $y(a) = b$. has only one solution is defined on I , if $f(x, y)$ & $\frac{\partial f}{\partial y}$ are continuous on some rectangle R in the xy -plane that contains the point (a, b) in its interior.

- Separable Equations

- Linear First-Order

$$\frac{dy}{dx} + P(x)y = Q(x), \quad y(x_0) = y_0$$

Integrating factor: $\rho(x) = e^{\int P(x)dx}$

- **Theorem** Unique solution for linear first-order equation

$P(x)$ and $Q(x)$ are continuous on the open interval I containing x_0

- Substitution Methods

$$* \frac{dy}{dx} = F\left(\frac{y}{x}\right) \longrightarrow v = \frac{y}{x}$$

- * Bernoulli Equation

$$\frac{dy}{dx} + P(x)y = Q(x)y^n \longrightarrow v(x) = y^{1-n}$$

- *Exactness (will not be tested on the final)*

$$M(x, y) + N(x, y) \frac{dy}{dx} = 0 \quad \frac{\partial M}{\partial y} = \frac{\partial N}{\partial x} \iff \text{exact in an open rectangle } R$$

- Reducible Second-Order Equations

- * Dependent variable y missing
- * Independent variable x missing

• Models in Chapter 1

- Natural Growth and Decay $\frac{dx}{dt} = kx$
- Newton's Cooling $\frac{dT}{dt} = k[A(t) - T]$
- Torricelli's Law

Suppose that a water tank has a hole with area a at its bottom, from which water is leaking. Denote by $y(t)$ the depth of water in the tank at time t , and by $V(t)$ the volume of water in the tank then. It is plausible – and true, under ideal conditions – that the velocity of water exiting through the hole is $v = \sqrt{2gy}$, which is the velocity a drop of water would acquire in falling freely from the surface of the water to the hole. As a consequence,

$$\frac{dV}{dt} = -av = -a\sqrt{2gy} \longrightarrow \frac{dV}{dt} = -k\sqrt{y} \quad \text{where } k = a\sqrt{2g}$$

Alternatively, Let $A(y)$ denote the horizontal cross-sectional area of the tank at height y .

$$\frac{dV}{dt} = \frac{dV}{dy} \cdot \frac{dy}{dt} = A(y) \frac{dy}{dt} \implies A(y) \frac{dy}{dt} = -a\sqrt{2gy} = -k\sqrt{y}$$

- Mixture Problem:

$\frac{dp}{dt}$ = Rate of change of p in time = rate pollution in – rate pollution out
 = (rate water in)(concentration pollutions in) – (rate water out) (concentration pollution out)

• Mathematical Models and Numerical Methods

- Population Models:
 $\beta(t)/\delta(t)$ - # of births/deaths per unit of per population per unit time at time t

$$\frac{dP}{dt} = [\beta(t) - \delta(t)] P$$

* Logistic equation $\frac{dP}{dt} = kP(M - P), \quad P(0) = P_0$

$$\implies P(t) = \frac{MP_0}{P_0 + (M - P_0)e^{-kMt}} \quad \lim_{t \rightarrow +\infty} P(t) = \frac{MP_0}{P_0 + 0} = M$$

M : limiting population / carrying capacity

- * A constant solution of a differential equation is sometimes called an **equilibrium solution**.
- * the critical point c is **stable** if, for each $\varepsilon > 0$, there exists $\delta > 0$ such that

$$|x_0 - c| < \delta \implies |x(t) - c| < \varepsilon$$

for all $t > 0$. Otherwise it is unstable.

- * Logistic Population with Harvest $\frac{dx}{dt} = kx(M - x) - h$

– Acceleration-Velocity Models

- * Resistance Proportional to Velocity

$$F_R = -kv. \quad m \frac{dv}{dt} = -kv - mg. \quad |v_\tau| = \frac{mg}{k}.$$

- * Resistance Proportional to Square of Velocity

$$F_R = -kv|v|. \quad m \frac{dv}{dt} = -mg - kv|v|. \quad |v_\tau| = \bar{v} = \sqrt{\frac{mg}{k}}$$

– Newton's Law of Gravitation: $F = \frac{GMm}{r^2}$

$$\left. \begin{aligned} \frac{dv}{dt} = \frac{d^2r}{dt^2} = -\frac{GM}{(R+y)^2} = -\frac{GM}{r^2} \\ \frac{d^2r}{dt^2} = \frac{dv}{dt} = \frac{dv}{dr} \frac{dr}{dt} = v \frac{dv}{dr} \end{aligned} \right\} \implies v \frac{dv}{dr} = -\frac{GM}{r^2} \implies v = \sqrt{v_0^2 + 2GM \left(\frac{1}{r} - \frac{1}{R} \right)}$$

Consider the interval of existence, we must have the radicand > 0 . Thus we can find the escape velocity $v = \sqrt{\frac{2GM}{R}}$.

– Numerical Approximation

- * $\frac{dy}{dx} = f(x, y), \quad y(x_0) = y_0. \quad \text{Step size } h. \quad y_{n+1} = y_n + hf(x_n, y_n).$

- * Improved Euler Method

$$\begin{aligned} k_1 &= f(x_n, y_n) \\ u_{n+1} &= y_n + h \cdot k_1 \quad \text{predictor} \\ k_2 &= f(x_{n+1}, u_{n+1}) \\ y_{n+1} &= y_n + h \cdot \frac{1}{2}(k_1 + k_2) \quad \text{corrector} \end{aligned}$$

• Dimensional Analysis

– Two principles

1. One can only add, subtract or equate physical quantities with the same physical dimensions.
2. Quantities with different dimensions may be combined by multiplication with dimensions.

– Dimensionless Variables

– Buckingham- π Theorem

$$Q_n = f(Q_1, \dots, Q_{n-1}) \quad \text{is equivalent to} \quad \pi_k = h(\pi_1, \dots, \pi_{k-1})$$

r independent fundamental physical dimensions. $k = n - r$.

– Pendulum Model

• Linear Equations of Higher order

– boundary value problem / initial value problem

- **Theorem** Principle of Superposition for Homogeneous Equations: $y = c_1 y_1 + c_2 y_2$ is also a solution on I .

- **Theorem** Existence and Uniqueness for Linear Equations: $y'' + p(x)y' + q(x)y = f(x)$ has unique solution on I that satisfies $y(a) = b_0, y'(a) = b_1$.

- homogeneous & nonhomogeneous (associated homogeneous)
- linear independence of functions
- Wronskian. Suppose the functions $f_1, \dots, f_n$ are $n-1$ times differentiable on some interval I :

$$W(f_1, \dots, f_n) = \det \begin{bmatrix} f_1 & \dots & f_n \\ \vdots & \ddots & \vdots \\ f_1^{(n-1)} & \dots & f_n^{(n-1)} \end{bmatrix}$$

$f_1, \dots, f_n$ linearly independent $\implies W(f_1, \dots, f_n) \equiv 0$ on I .

- **Theorem** General Solution for a Linear Homogeneous Equation.

$$y^{(n)} + P_1(x)y^{(n-1)} + \dots + P_n(x)y = 0 \quad (3.1)$$

Let $\phi(x)$ be any solution of (3.1), $y_1, \dots, y_n$ be linearly independent solutions on I , then there exists $c_1, \dots, c_n$ such that

$$\phi(x) = \sum_{i=1}^n c_i y_i(x), \quad \forall x \in I$$

Note the difference from Superposition Theorem... I got no marks on proving this in midterm...

Proof ($n=2$) Let $\phi(x)$ be a solution of (3.1) on I . Let $a \in I$. Consider the linear system.

$$(*) \quad \begin{bmatrix} y_1(a) & y_2(a) \\ y_1'(a) & y_2'(a) \end{bmatrix} \begin{pmatrix} c_1 \\ c_2 \end{pmatrix} = \begin{pmatrix} \phi(a) \\ \phi'(a) \end{pmatrix}$$

Since y_1, y_2 are linearly independent on I , $W(y_1, y_2) \neq 0$ on I . Thus $\det(M) \neq 0$ and $(*)$ has a solution

$$\begin{pmatrix} c_1 \\ c_2 \end{pmatrix} = M^{-1} \begin{pmatrix} \phi(a) \\ \phi'(a) \end{pmatrix}$$

Using these values of c_1, c_2 define

$$y(x) = c_1 y_1(x) + c_2 y_2(x)$$

Then $y(x)$ satisfies the IVP on I consisting of (3.1) and $y(a) = \phi(a), y'(a) = \phi'(a)$. But $\phi(a)$ also satisfies this IVP on I . So by E/U we must have:

$$\phi(x) = y(x) = c_1 y_1(x) + c_2 y_2(x) \quad x \in I$$

In other words, given $y_1, \dots, y_n$ linearly independent solutions of (3.1), and arbitrary constants $c_1, \dots, c_n$

$$c_1 y_1(x) + \dots + c_n y_n(x)$$

is a general solution of (3.1). □

- General Solution for a Linear Non-Homogeneous Equation.
- Homogeneous, linear ODEs with constant coefficients

* characteristic equation/polynomial: $a_n r^n + \dots + a_1 r + a_0 = 0$

* Three cases: (c_i are arbitrary constants)

- Linear independence verification uses Wronskian.

- Proofs of the last two involve differential operator D

1. distinct real roots: $y = c_1 e^{r_1 x} + \dots + c_n e^{r_n x}$

2. repeated real roots (multiplicity k): $e^{\bar{r}x}, xe^{\bar{r}x}, \dots, x^{k-1}e^{\bar{r}x}$

3. complex roots $(\alpha \pm i\beta)$: $e^{\alpha x} \cos(\beta x), e^{\alpha x} \sin(\beta x)$

2 & 3. Repeated complex roots:

$$e^{\alpha x} \cos(\beta x), e^{\alpha x} \sin(\beta x), \dots, x^{k-1}e^{\alpha x} \cos(\beta x), x^{k-1}e^{\alpha x} \sin(\beta x)$$

– Application

* Mass spring damp: $mx'' + cx' + kx = 0$

* pendulum: $s = l\theta, \quad ml\theta'' = -mg \sin(\theta)$

Two models are of the same form $y'' + b_1y' + b_0y = 0$

$b_1 = 0$			simple harmonic motion
$b_1^2 - 4b_0 < 0$	two complex root	underdamped	oscillatory with amplitude decaying
$b_1^2 - 4b_0 = 0$	one real repeated root	critically damped	not oscillatory
$b_1^2 - 4b_0 > 0$	two real roots	overdamped	not oscillatory

– Non-homogeneous DE

* Undetermined Coefficients

* Variation of Parameters

* Application

· Forced, undamped motion: resonance and beating

· Forced, damped motion: practical resonance

• Linear Systems of DEs

– definition $\mathbf{x}' = \underbrace{P(t)}_{\substack{\text{coefficient} \\ \text{matrix}}} \mathbf{x} + \mathbf{f}(t), \quad \mathbf{x}(t_0) = \mathbf{x}_0$

– E/U: $P(t), \mathbf{f}(t)$ are continuous on an open interval I containing point t_0 , then there exists a unique solution on I .

– Superposition

– Wronskian of $\mathbf{x}_1, \dots, \mathbf{x}_n$ (which are solutions of $\mathbf{x}' = P(t)\mathbf{x}$) is

$$W(\mathbf{x}_1, \dots, \mathbf{x}_n) = \det(M) = \det \begin{bmatrix} \mathbf{x}_1(t) & \dots & \mathbf{x}_n(t) \end{bmatrix} = \det \begin{bmatrix} x_{11}(t) & \dots & x_{n1}(t) \\ \vdots & \ddots & \vdots \\ x_{1n}(t) & \dots & x_{nn}(t) \end{bmatrix}$$

dependent, $W \equiv 0$; independent, $W \neq 0, \forall t \in I$.

– General Solution of Homogeneous/Non-Homogeneous Linear Systems

$$\vec{x}' = P(t)\vec{x} \tag{3.2}$$

Proof of Homogeneous one (responsible for final)

Proof

► Let $\vec{x}(t)$ be any solution on I of (3.2). Let $t_0 \in I$, and $M(t)$ be as in the definition of the Wronskian. Since $\vec{x}_1, \dots, \vec{x}_n$ are linearly independent on I ,

$$\det(M(t_0)) = W(\vec{x}_1(t_0), \dots, \vec{x}_n(t_0)) \neq 0$$

Thus the linear system $M(t_0)\vec{c} = \vec{x}(t_0)$ (*)

has a unique solution

$$\vec{c} = M^{-1}(t_0)\vec{x}(t_0) = \begin{pmatrix} c_1 \\ c_2 \\ \vdots \\ c_n \end{pmatrix}$$

3. AMATH

Define $\vec{y}(t) = c_1\vec{x}_1(t) + \dots + c_n\vec{x}_n(t)$. This is a solution of (3.2) by the Superposition Principle and satisfies the initial condition $\vec{y}(t_0) = \vec{x}(t_0)$. But $\vec{x}(t)$ is also a solution of (3.2) satisfying the same IC. By the E/U Theorem we must have

$$\vec{x}(t) = \vec{y}(t) = c_1\vec{x}_1(t) + \dots + c_n\vec{x}_n(t) \quad \forall t \in I$$

□

– Eigenvalue Method ¹

$\lambda_1, \lambda_2 \in \mathbb{R}$	$\mathbf{v}_1, \mathbf{v}_2$	$c_1 e^{\lambda_1 t} \mathbf{v}_1 + c_2 e^{\lambda_2 t} \mathbf{v}_2$
λ	$\mathbf{v}, \mathbf{u}$	$c_1 e^{\lambda t} \mathbf{v} + c_2 (e^{\lambda t} \mathbf{u} + t e^{\lambda t} \mathbf{v})$

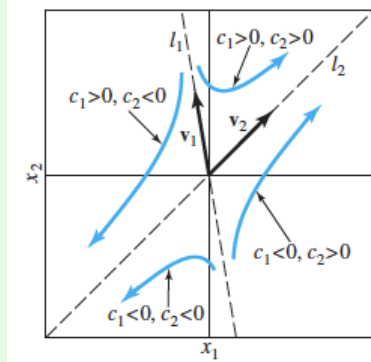


FIGURE 5.3.1. Solution curves $\mathbf{x}(t) = c_1 \mathbf{v}_1 e^{\lambda_1 t} + c_2 \mathbf{v}_2 e^{\lambda_2 t}$ for the system $\mathbf{x}' = \mathbf{A}\mathbf{x}$ when the eigenvalues λ_1, λ_2 of $\mathbf{A}$ are real with $\lambda_1 < 0 < \lambda_2$.

* Nodes (sink): distinct negative eigenvalues. Origin: improper nodal sink

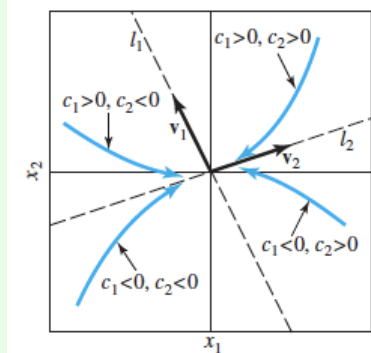


FIGURE 5.3.2. Solution curves $\mathbf{x}(t) = c_1 \mathbf{v}_1 e^{\lambda_1 t} + c_2 \mathbf{v}_2 e^{\lambda_2 t}$ for the system $\mathbf{x}' = \mathbf{A}\mathbf{x}$ when the eigenvalues λ_1, λ_2 of $\mathbf{A}$ are real with $\lambda_1 < \lambda_2 < 0$.

¹ $(A - \lambda I)\mathbf{u} = \mathbf{v}$, $\mathbf{u}$ is a generalized eigenvector of λ

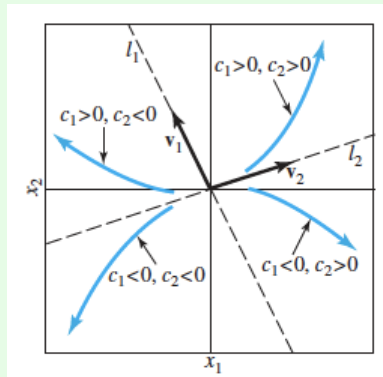


FIGURE 5.3.3. Solution curves $\mathbf{x}(t) = c_1 \mathbf{v}_1 e^{\lambda_1 t} + c_2 \mathbf{v}_2 e^{\lambda_2 t}$ for the system $\mathbf{x}' = \mathbf{A}\mathbf{x}$ when the eigenvalues λ_1, λ_2 of $\mathbf{A}$ are real with $0 < \lambda_2 < \lambda_1$.

 - with two independent eigenvectors. Origin: proper nodal source

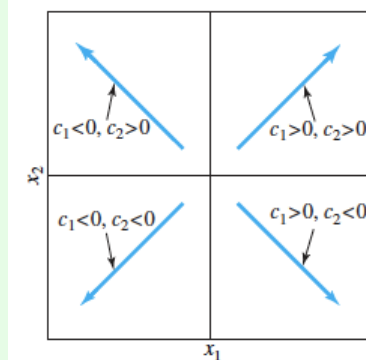


FIGURE 5.3.6. Solution curves $\mathbf{x}(t) = e^{\lambda t} \begin{bmatrix} c_1 \\ c_2 \end{bmatrix}$ for the system $\mathbf{x}' = \mathbf{A}\mathbf{x}$ when $\mathbf{A}$ has one repeated positive eigenvalue and two linearly independent eigenvectors.

- without two independent eigenvectors. Origin: improper nodal source

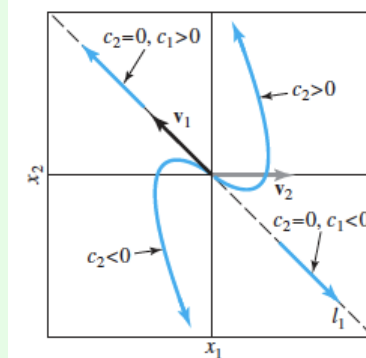
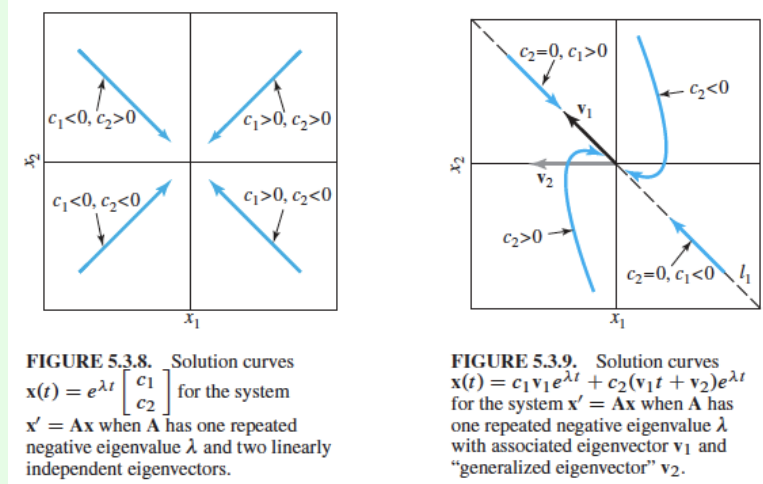


FIGURE 5.3.7. Solution curves $\mathbf{x}(t) = c_1 \mathbf{v}_1 e^{\lambda t} + c_2 (\mathbf{v}_1 t + \mathbf{v}_2) e^{\lambda t}$ for the system $\mathbf{x}' = \mathbf{A}\mathbf{x}$ when $\mathbf{A}$ has one repeated positive eigenvalue λ with associated eigenvector $\mathbf{v}_1$ and “generalized eigenvector” $\mathbf{v}_2$.

 - with two independent eigenvectors. Origin: proper nodal sink (5.3.8)

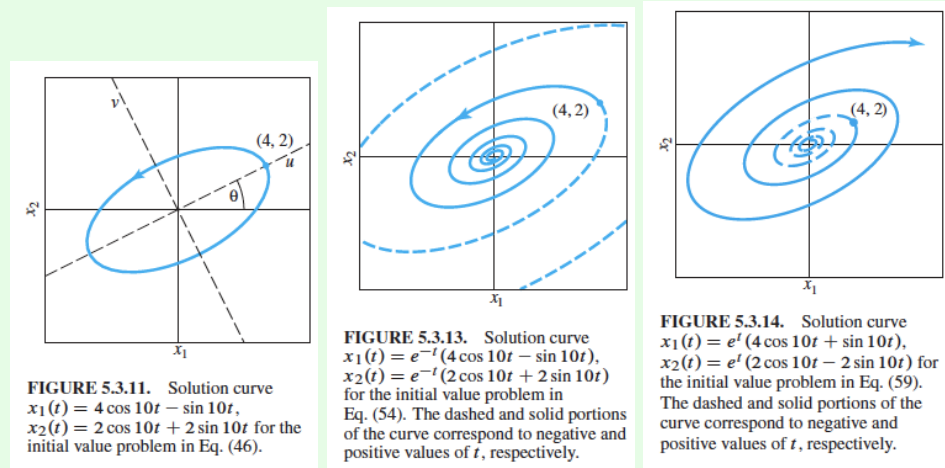

- Definitions: $F(s) = \mathcal{L}\{f(t)\} = \int_0^\infty e^{-st} f(t) dt$
- Unit step: $u_a(t) = u(t-a) = \begin{cases} 0 & t < a \\ 1 & t \geq a \end{cases}$
- exponential order: $|f(t)| \leq Me^{ct}$, for $t \geq T$ (2)
- Existence of the Laplace Transform (responsible for final): If f is piecewise continuous on $t \geq 0$ and of exponential order as $t \rightarrow \infty$ with constant c in eq(2), then $\mathcal{L}\{f(t)\} = F(s)$ exists for $s > c$.
converge absolutely $\implies$ converges $\implies$ exists for $s > c$

Proof

► Since f is piecewise continuous on $t \geq 0$, we can find $M \geq 0$ such that (2) is satisfied with $T = 0$. i.e.

$$|f(t)| \leq Me^{ct}, \quad \text{for } t \geq 0$$

$\int_0^\infty Me^{ct} e^{-st} dt$ converges if $s > c$. Thus using a comparison theorem $\int_0^\infty |f(t)e^{-st}| dt$ converges for $s > c$.

It follows that $\int_0^\infty f(t)e^{-st} dt$ converges. □

- Gamma function
- Uniqueness of the Inverse Laplace Transform

If $f(t)$ is piecewise continuous on $t \geq 0$ and is of exponential order as $t \rightarrow \infty$ (with constants c, T, M) then

$$\mathcal{L}\left\{\int_0^t f(\tau) d\tau\right\} = \frac{1}{s} \mathcal{L}\{f(t)\} = \frac{F(s)}{s} \quad \text{for } s > c$$

equivalently:

$$\mathcal{L}^{-1}\left\{\frac{F(s)}{s}\right\} = \int_0^t f(\tau) d\tau$$

Proof

► Since f is piecewise continuous, on $t \geq 0$. $g(t) = \int_0^t f(\tau) d\tau$ is continuous on $t \geq 0$, g' is piecewise continuous on $t \geq 0$.

Further,

$$|g(t)| = \left|\int_0^t f(\tau) d\tau\right| \leq \int_0^t |f(\tau)| d\tau \leq \int_0^t Me^{c\tau} d\tau = \frac{M}{c}(e^{ct} - 1) \leq \frac{M}{c}e^{ct} \quad t \geq 0$$

So $g(t)$ is of exponential order as $t \rightarrow \infty$ and we can apply the Theorem on Laplace Transform of Derivatives.

$$\begin{aligned} \mathcal{L}\{f(t)\} &= \mathcal{L}\{g'(t)\} = s\mathcal{L}\{g(t)\} - g(0) = s\mathcal{L}\{g(t)\} & \text{for } s > c \\ \implies \mathcal{L}\left\{\int_0^t f(\tau) d\tau\right\} &= \mathcal{L}\{g(t)\} = \frac{1}{s} \mathcal{L}\{f(t)\} & \text{for } s > c \end{aligned}$$

□

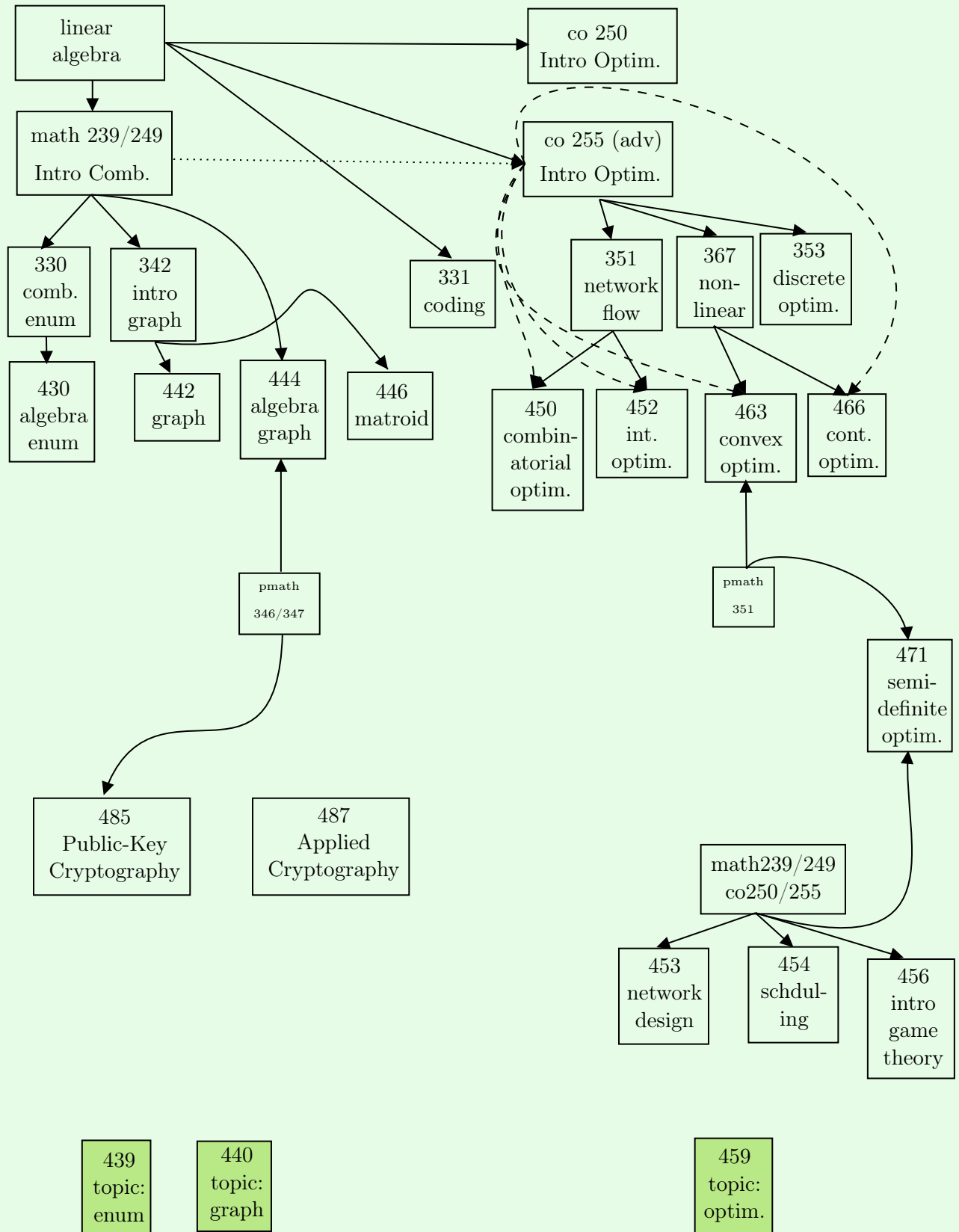

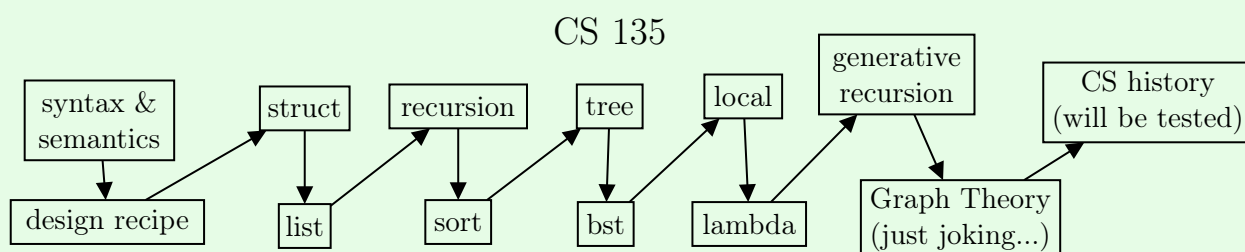

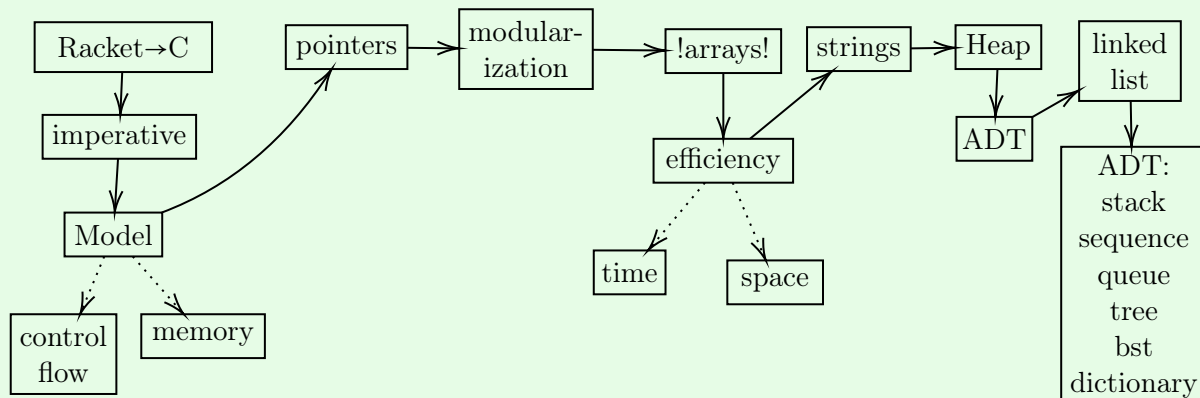
