About Form 966, Corporate Dissolution or Liquidation. A corporation (or a farmer's cooperative) files this form if it adopts a resolution or plan to dissolve the corporation or liquidate any of its stock.

Procedure for voluntary dissolution. Voluntary dissolution is a two-step process: Obtaining written consent from the Tax Department (which will check to see if the corporation owes back taxes and if it has filed all its returns); and Filing paperwork with the New York Department of State, including a Certificate of Dissolution.

### **Instructions for voluntary dissolution of a New York ...**

File your petition with the clerk and pay the filing fee. Attend the hearing set by the court and swear before the judge that both of you signed the separation agreement and petition for dissolution voluntarily, that you still agree to the terms of your separation agreement, and that you both want a dissolution of the marriage.

As a result, the corporation had to file Form 966 within 30 days after the date on which the certificate of voluntary dissolution was executed and filed with the proper officer of the state. In addition, a certified copy of the certificate of voluntary dissolution had to be attached to the return in lieu of a copy of a corporate resolution or plan.
