1. COMPANY PROFILE

Container Corporation of India Limited (CONCOR) was incorporated under the Indian Companies Act, 1956 with the objective to serve as a catalyst for boosting India's EXIM and Domestic trade and commerce by providing efficient and reliable multimodal logistic support and to ensure growing stakeholder value. The company provides the services for containerized freight transportation by rail in India. CONCOR is a Schedule - 'A', Nav Ratna CPSE in transportation services sector under the administrative control of Ministry of Railways.

Its registered and corporate offices are in New Delhi.

The authorised and paid up capital of the Company was Rs. 200 crore and 194.97 crore respectively as on March 31, 2014.

The shareholding of the Government of India is 61.80%.

2. JOB DESCRIPTION AND RESPONSIBILITIES:

Director (Domestic Division) is a member on the Board of Directors of the Corporation and reports to the Chairman and Managing Director. He would be primarily responsible for efficient function of Domestic Division by evolving effective marketing strategies for business development and promotion of multimodal rail-cum-road movement of containerised traffic. His responsibilities include overseeing the running of domestic container trains and maintaining liaison with concerned Railway authorities, regarding train running; he would also be responsible to oversee the development and functioning of domestic container terminals and prescribe systems and procedures for operation of these terminals; and he would be responsible to arrange stevedoring and road transportation arrangements at these terminals.

II. Employment Status:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – as one of the following:-

- (i) An officer of a Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (ii) An officer of the Central Government/ Armed Forces of the Union;
- (iii) An officer of an All India Service.

III. QUALIFICATION AND EXPERIENCE:

The incumbent should be a graduate with good academic record from a recognised university/institution. He should possess adequate experience at a senior level of management in Railway operations, multimodal transportation traffic policy, marketing, sales forecasting and planning and execution of business strategies in large transport organisation of repute preferably a railway organisation.

Experience in Human Resource planning and execution of HR would be desirable qualifications.

IV. PAY SCALE:

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.

- (b) Officers of Central Govt/ Armed Forces of the Union/ All India Services

Candidate should, on the date of application, be in the following or a higher pay scale/ rank:

- (i) Officers of Central Govt./ All India Services holding a post of the level of Joint Secretary in Govt. of India or carrying equivalent scale of pay;
- (ii) Officers of Armed Forces:- Major General in the Army or equivalent rank in Navy/Air Force.

V. Condition of Immediate Absorption for Government Officers

Government Officers, including those of the Armed Forces, will be eligible for consideration only on immediate absorption basis.

4. DURATION OF APPOINTMENT

The appointment shall be for a period of five years or upto the date of superannuation whichever is earlier.

5. SUBMISSION OF APPLICATIONS

Prospective candidates from the Central Public Sector and Government officers shall submit their applications, through proper channel, in the format at Annexure.

The applications for various categories of the officers are routed through proper channel as follows:

- a) For Government Servants: through Cadre Controlling authority.
- b) For CMD's/MD's/Director's in CPSE: through the concerned administrative Ministry.
- c) For below Board level in CPSE: through the concerned CPSE.

6. CERTIFICATION BY CANDIDATE

- a) Candidate has to submit his/her willingness for the post at the time of interview itself clearly stating that he/she will join the post, if selected. If any candidate, does not initially give his/her willingness, he/she will not be interviewed.
- b) If any of the candidates who appeared for the interview and is selected by the PESB, gives his/her unwillingness after the interview is held, but before the appointment is processed, would be debarred for a period of two years for being considered for a Board level post in any PSE other than the one to which the candidate belongs.
- c) If any candidate gives his/her unwillingness after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment from being considered for a Board level post in any PSE other than the one to which the candidate belongs.
- d) In the above cases, no request for relaxation or otherwise would be entertained.
