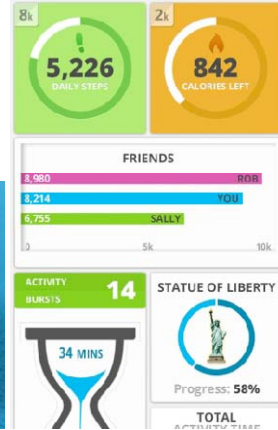
1. The device can be charging by PC USB port
