### Wireless Interoperability

The Intel(R) Wireless WiFi Link 4965AGN products are designed to be interoperable with any wireless LAN product that is based on Direct Sequence Spread Spectrum (DSSS)/Orthogonal Frequency Division Multiplexing(OFDM) radio technology, and is compliant to:

The IEEE 802.11 Standard on Wireless LANs(Revision A/B/G and N Draft Ver.1.0), as defined and approved by the Institute of Electrical and Electronics Engineers.

The Wireless Fidelity(Wi-Fi) certification as defined by the Wi-Fi Alliance. The “Wi-Fi CERTIFIED” logo is a certification mark of the Wi-Fi Alliance.

### CAUTION

Bluetooth<sup>®</sup> and WirelessLAN devices operate within the same radio frequency range and may interfere with one another. If you use Bluetooth and WirelessLAN devices simultaneously, you may occasionally experience a less than optimal network performance or even lose your network connection.

To prevent radio interference to the licensed service, this device is intended to be operated indoors and away from windows to provide maximum shielding. Equipment (or its transmit antenna) that is installed outdoors is subject to licensing.

## USA-Federal Communications Commission (FCC)

## Caution: Exposure to Radio Frequency Radiation.

The radiated output power of the Intel(R) Wireless WiFi Link 4965AGN is far below the FCC radio frequency exposure limits. Nevertheless, the Intel(R) Wireless WiFi Link 4965AGN shall be used in such a manner that the potential for human contact during normal operation is minimized. In normal operating configuration, the LCD in the upright position, the distance between the antenna and the user should not be less than 20cm.(regular type)The antenna(s) used in this device are located at the upper edge of the LCD screen, and this device has been tested as portable device as defined in Section 2.1093 of FCC rules when the LCD screen is rotated 180 degree and covered the keyboard area.(tablet type) In addition, Wireless LAN has been tested

with Bluetooth transceiver for co-location requirements. This device and its antenna(s) must not be co-located or operating in conjunction with any other antenna or transmitter. Antenna(s) used in 5.15-5.25GHz frequency band must be integral antenna which provide no access to the end user. Refer to the Regulatory Statements as identified in the documentation that comes with those products for additional information. The installer of this radio equipment must ensure that the antenna is located or pointed such that it does not emit RF field in excess of Health Canada limits for the general population; consult Safety Code 6, obtainable from Health Canada's website [www.hc-sc.gc.ca/rpb](http://www.hc-sc.gc.ca/rpb).

## **Taiwan**

### **Article 12**
