

#### **To Insert Batteries in Plane:**

Remove screws on battery compartment door located on bottom of vehicle.

Insert 2 "AA" batteries (alkaline recommended) Be sure the (+) and (-) are properly matched. Replace battery door and tighten screw.

#### To onsure proper function:


Do not mix old and new batteries.



# To Insert Batteries in Transmitter:


Push transmitter back battery cover in the direction of the arrow. Insert 1-9Volt battery and replace door.



- Operating the Vehicle: 1. Turn on the vehicle 2. Operate vehicle with included transmitter OFF ON BACK VIEW 3. Press the Push Button to go straight



4. To change directions let the push button go and the Stuart Little RC Plane spins. Press the Push button again when the plane is in the direction you would like to go.



5. Turn off plane after operating

# **Safety Precautions:**

### Caution:

- Do not pick up vehicle while in motion.
- Keep fingers, hair and loose clothing away from the tires and the wheel hubs while the vehicle is operation mode.
- To avoid accidental operation, remove battery pack when not in use.
- 1. Radio interference is caused by the presence of another radiocontrolled vehicle operating on the same frequency as our plane.
- 2. Radio interference can be caused by the operation of your plane near high voltage electrical wires, large steel reinforced concrete buildings and passing trucks with CB radios.
- 3. Do NOT operate your plane over wet surfaces. Water can damage the internal electronic assemblies.
- 4. Do NOT drive your remote control vehicle into the streets.
- 5. For best results, hold antenna up, not pointed down toward the R/C vehicle. Too far away from the transmitter, your signal strength will become weak and the plane will not function property. The maximum range for the plane should be between 13 to 22 feet depending on conditions.
